
Read this manual carefully before use, and retain it for future reference.

This appliance can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved. 




Installation




Loosen the battery cover counterclockwise.



Correctly align the batteries with the positive and negative symbols (+/-) when inserting them.



Align the unlocked symbol on the battery cover with the triangular symbol on the side of the dispenser.



Turn the battery cover clockwise until the lock symbol aligns with the triangular symbol.



Unscrew the hand soap cover counterclockwise, and remove the silicon plug.



Align the hand soap with the bottom of the dispenser and gently turn it counterclockwise until it is secure.

Instructions



Tap the On/Off button to turn on the Mi Automatic Soap Dispenser.



It is recommended to first rinse your hands with water to moisten them.



Move your hands into the sensor area to dispense foam.



It is recommended to thoroughly rub your hands.



Dry your hands after washing them with water.

Note: When the soap dispenser is not being used, it will automatically go into standby mode. It is not necessary to manually turn it off.

Status	Indicator Light Status
On	White remains on for 1.5 seconds
Off*	Orange blinks and turns off shortly
Low battery	Orange remains on for 3 seconds after the sensor is triggered
Error (the sensor area is blocked by foam)	Orange blinks quickly

^{*}When the dispenser is on, tap the On/Off button to turn it off.

Maintenance

- For cleaning, it is recommended to gently wipe the surface of the device with a wet towel when it is turned off.
- If the product will not be used for a long time, please take out the batteries to avoid them from getting damp or starting to leak.

Precautions

- Do not immerse the product in water nor rinse it directly with water to avoid short circuits.
- Do not tilt the bottle when installing or replacing the hand soap. It is normal if a small amount of liquid overflows, it can still be used normally after wiping it clean.
- Do not use non-foaming hand soap in order to avoid the device from malfunctioning.
- Store this product in a cool place away from direct sunlight or heat sources.
- Only use the dispenser when the batteries and the compartment are thoroughly dry.
 In case the dispenser encounters any water spray, inversion, or tilt, immediately check the batteries and the compartment.
- Please recycle the used batteries.

Troubleshooting

Fault	Possible Causes	Solutions
Cannot turn on/off	Incorrectly installed the battery's positive and negative.	Reinstall the batteries.
Indicator does not light up	The product is not turned on yet. Incorrectly installed the battery's positive and negative.	Turn it on. Reinstall the batteries.
Cannot produce foam	The hand soap has been used up. The batteries are depleted.	Replace the hand soap. Replace the batteries with new ones.
Quickly blinking orange	The sensor area is blocked by foam.	Turn the product off, clean the sensor area and turn it on again.
