

- This product is intended to play audio via a 3.5 mm audio jack connector.
- This product is intended for household use only. It is not intended for commercial use.

- The apparatus shall not be exposed to dripping or splashing and no objects filled with liquid shall be placed on the apparatus.
- This product is intended to be used in dry indoor areas only.

#### Connection

- 1. Connect the product's USB cable to the USB slot of your computer.
- 2. Connect the 3.5 mm audio jack connector to the audio output jack of your computer.

## Operation

- 1. Turn the volume control knob in the clockwise direction to turn the product on. The LED lights up blue.
- 2. Keep turning in the clockwise direction to increase the volume level.
- 3. To turn off, turn the volume control knob all the way in the anti-clockwise direction. The LED goes off.

**NOTICE** The volume can also be controlled via your computer volume settings. If the product does not play audio, ensure the audio output of your computer is not muted.

# sing Headphones (not included)

**NOTICE** Do not listen to music at a high volume for an extended period of time. This may damage your hearing.

- 1. Connect the 3.5 mm audio jack connector of your headphones to the product's audio output jack.
- 2. The volume can be controlled with the volume control knob.

**NOTICE** After connecting the external headphones the product is muted automatically.

# **Cleaning and Maintenance**

- To clean, wipe with a soft, slightly moist cloth.
- Dry the product after cleaning.
- Never use corrosive detergents, wire brushes, abrasive scourers, metal or sharp utensils to clean the product.
