

Promotion Terms and Conditions

- With VAT Services on Amazon, you can complete your VAT registration, filing, and submission in Seller Central
 for up to 7 countries the UK, Germany, France, Italy, Spain, Poland, and the Czech Republic ("Countries").
 Amazon works with tax agents that provide the tax compliance services to you through the VAT Services on the
 Amazon interface. VAT Services on Amazon does not support VAT filings in the country of your place of
 establishment.
- 2. Amazon will rebate the fees (excluding VAT) for fiscal representation and VAT filing for the first 6 months after the first filing is generated with VAT services on Amazon in respect to the Countries you select during the registration process.
- 3. Amazon may stop offering this promotion at any time by the withdrawal of the offer text. Amazon will not be obliged to place a notice or otherwise notify of the promotion's withdrawal. Amazon may modify the terms of this promotion at any time.
- 4. If during the first 6 months of using VAT filing services, your agreement with the tax agent or your VAT Services on Amazon Online Agreement is terminated for your breach, you authorize Amazon Services Europe S.a.r.l. and its affiliates Amazon Payments Europe S.C.A. and Amazon Payments UK Limited, as applicable, to charge an amount equivalent to the promotion benefit (total amount rebated at the time of registration) in accordance with the VAT Services on Amazon Online Agreement.
