It's widely used in communities, schools, hospitals, airports, trains station, etc.

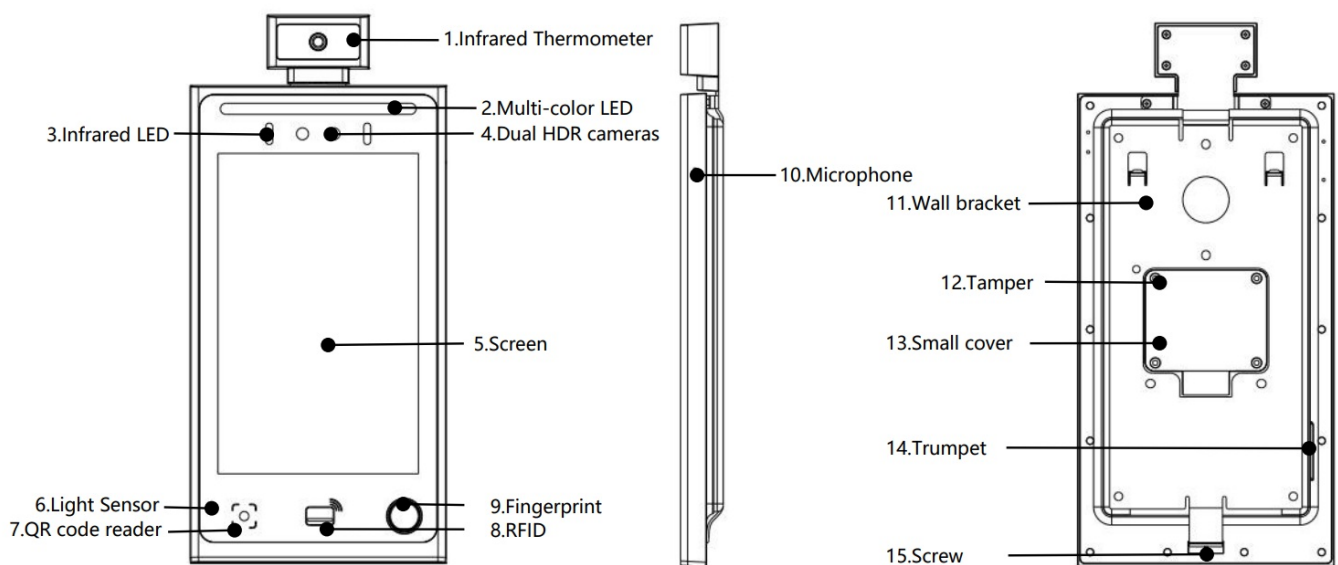
### HD wide dynamic camera

### Binocular live detection

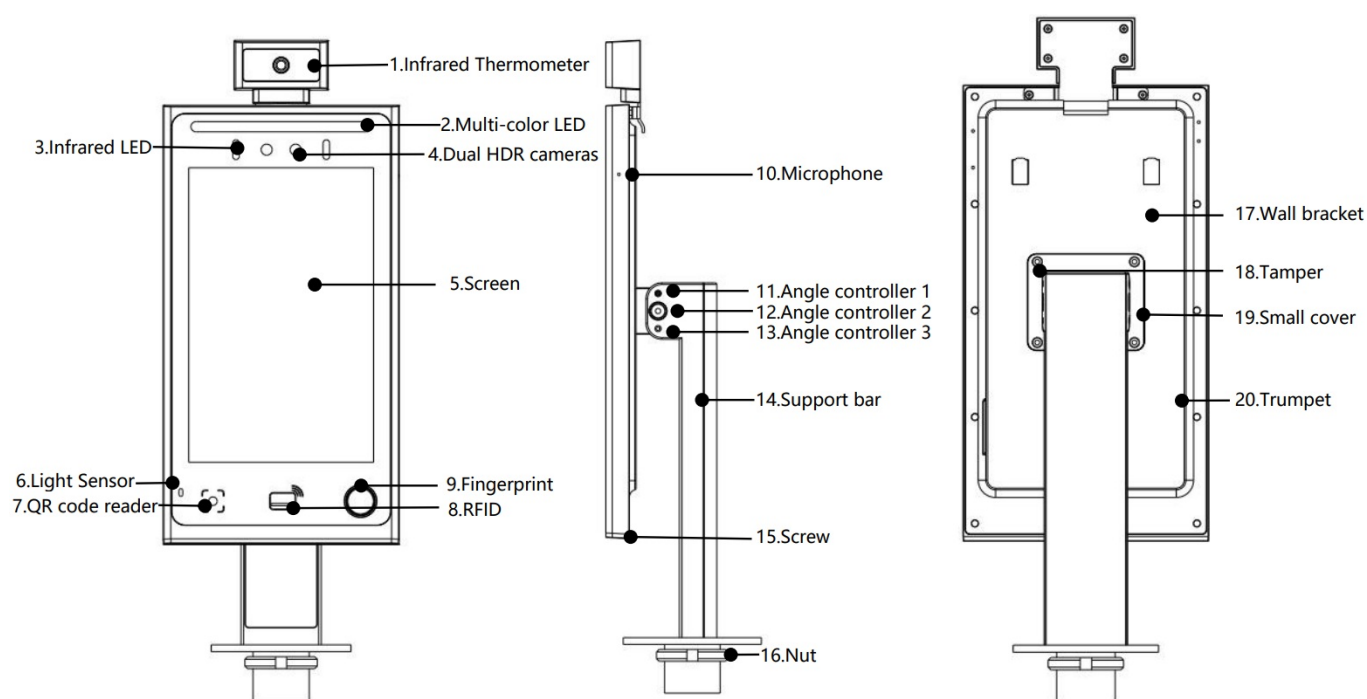
Built-in visible light and infrared dual cameras can automatically complete hardware live detection, effectively rejecting non-living attacks such as photos and videos.

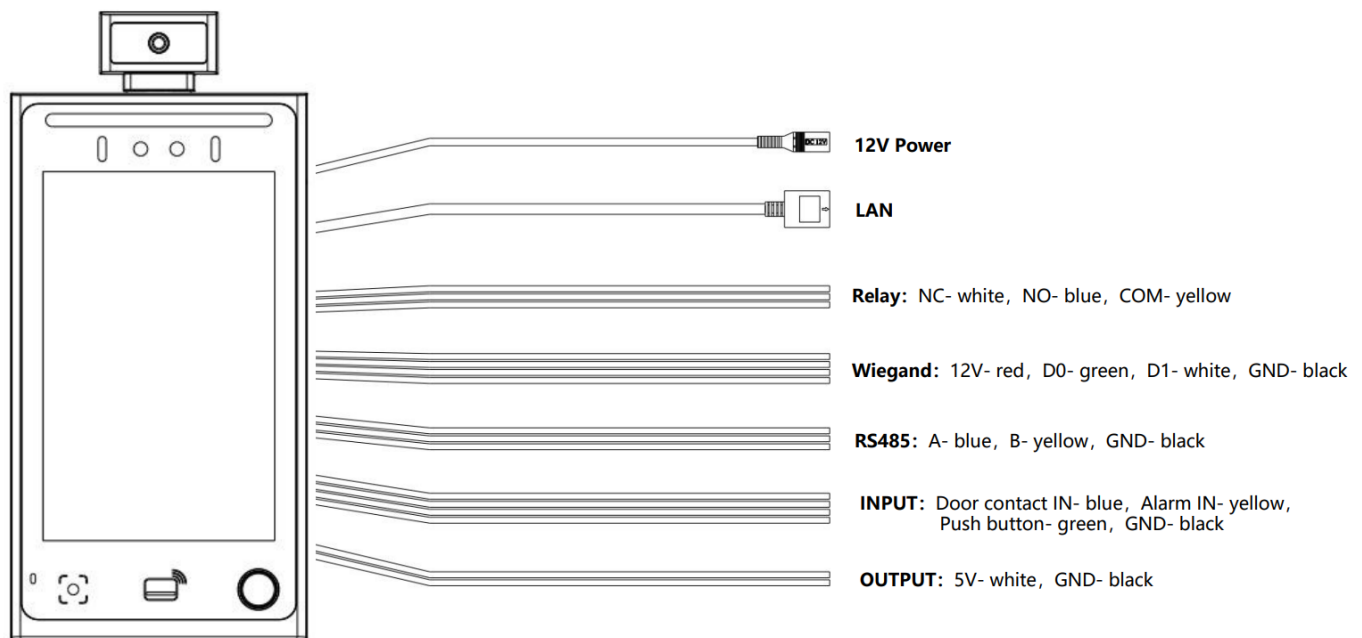

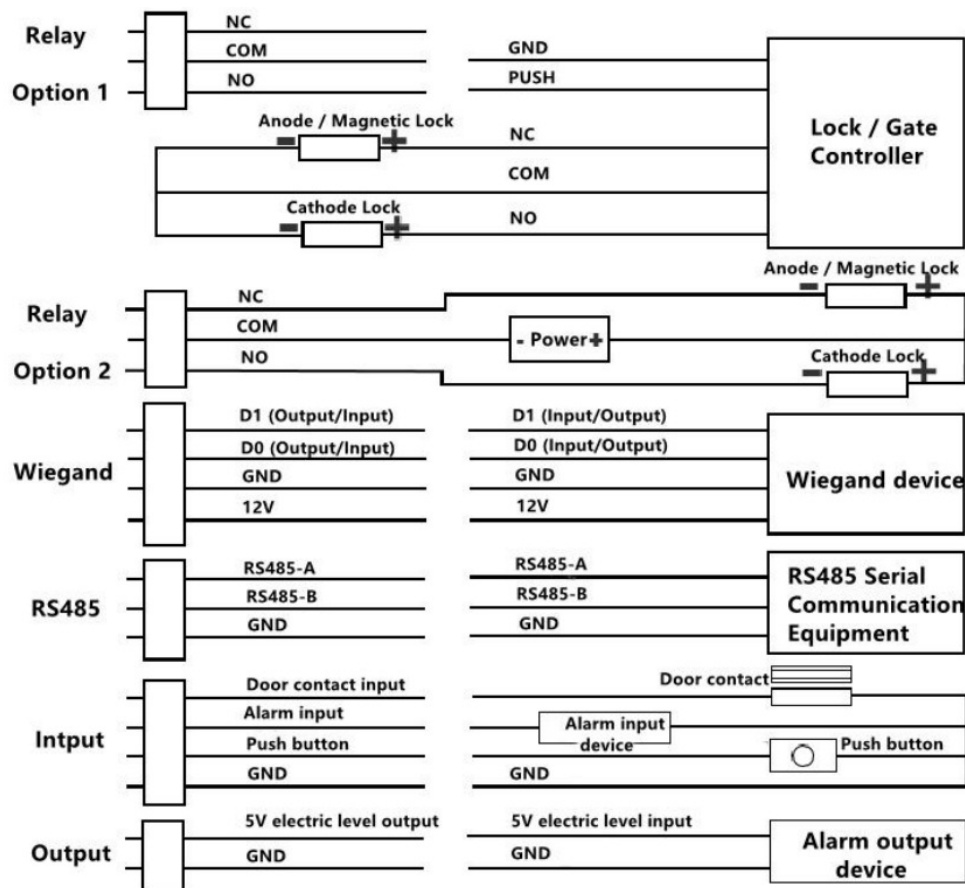
