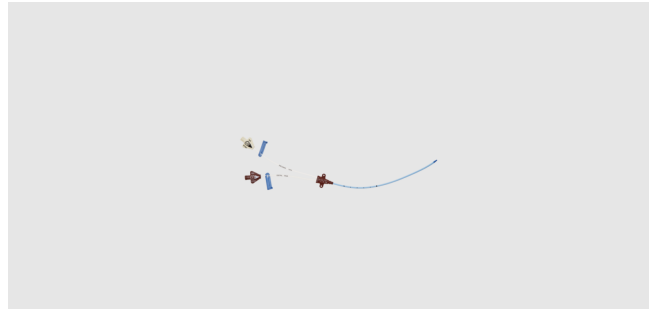

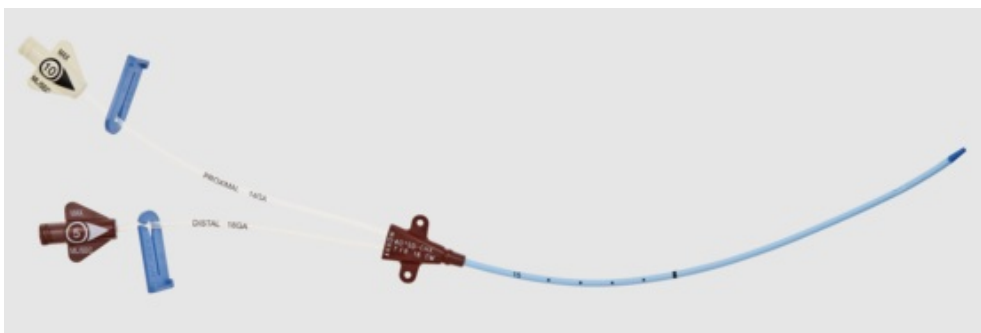

- Arrowg+ard Blue® Two-Lumen Catheter: 7 Fr. (2.5 mm OD) x 16 cm, Pressure Injectable
- 1: Spring-Wire Guide, Marked: .025" (0.64 mm) dia. x 23-5/8" (60 cm) (Straight Soft Tip on One End – "J" Tip on Other) with Arrow Advancer
- 1: Catheter: 20 Ga. x 1-3/4" (4.45 cm) Radiopaque over 22 Ga. TW Introducer Needle
- 1: Introducer Needle: Echogenic 18 Ga. x 2-1/2" (6.35 cm) RW
- 1: Injection Needle: SafetyGlide™1 25 Ga. x 1" (2.54 cm)

Priming volumes are approximate and are done without accessories. Flow rate values are approximate and are determined using deionized water at 100 cm head height. Pressure injection flow rates are determined using media of 11.8 centipoise (cP) viscosity, with 152 cm administration set tubing.
