




## Product Usage Instructions

- Do not use the product outdoors.
- Read and understand the instructions before installation.
- The product must be properly installed before use.
- Failure to follow instructions voids the warranty.
- Follow the mounting bracket installation steps provided in the manual.
- Connect the black wire (L) to the corresponding terminal and the white wire (N) to its terminal according to instructions.
- Follow the instructions for installing the light fixture properly.
- Use the tunable white technology features as per your preferences.

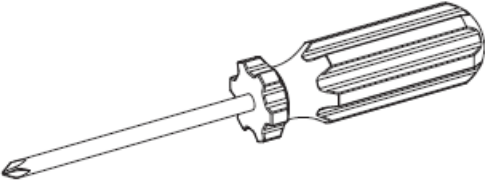
## FAQ

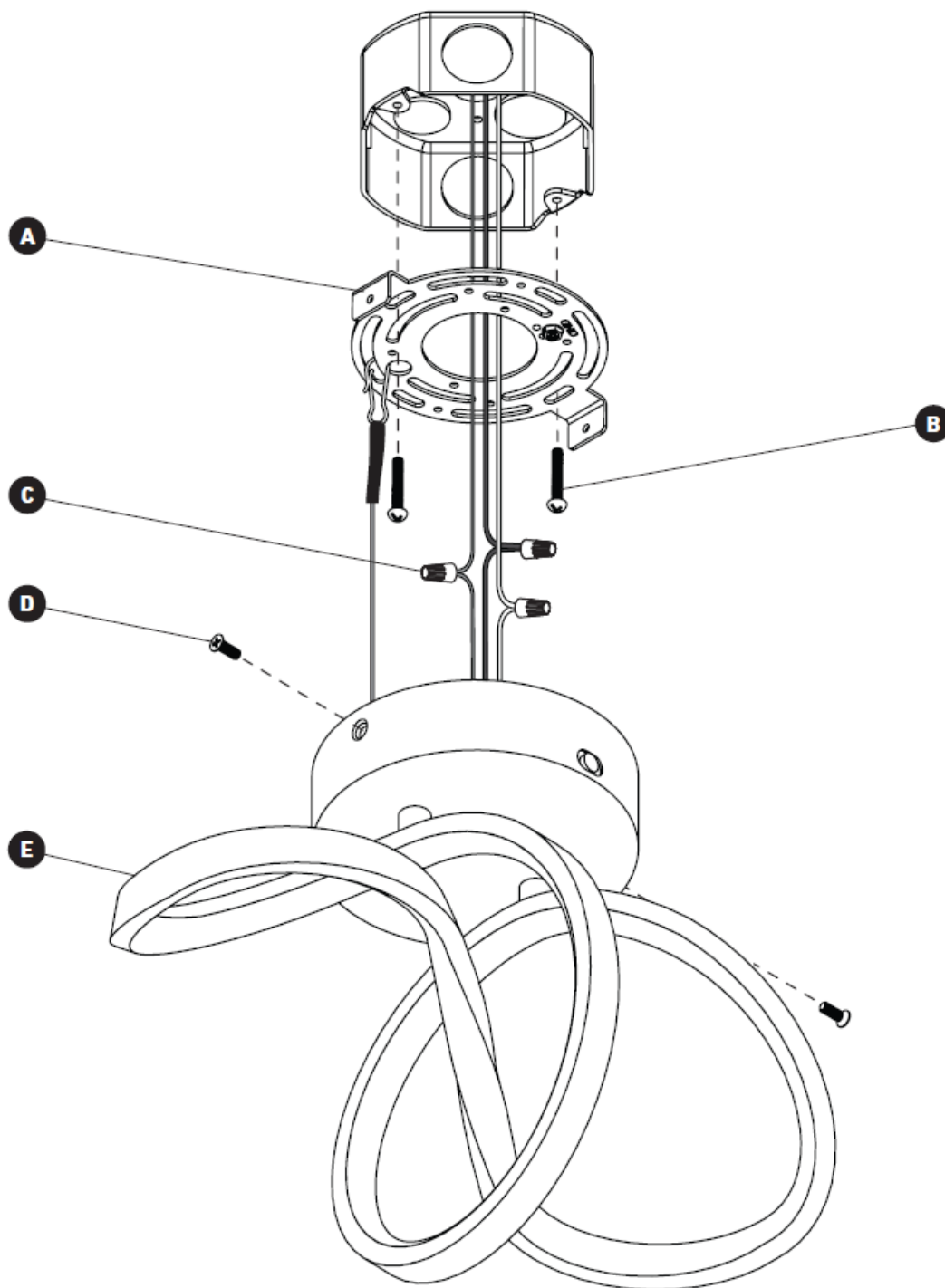

- Do not use outdoors.

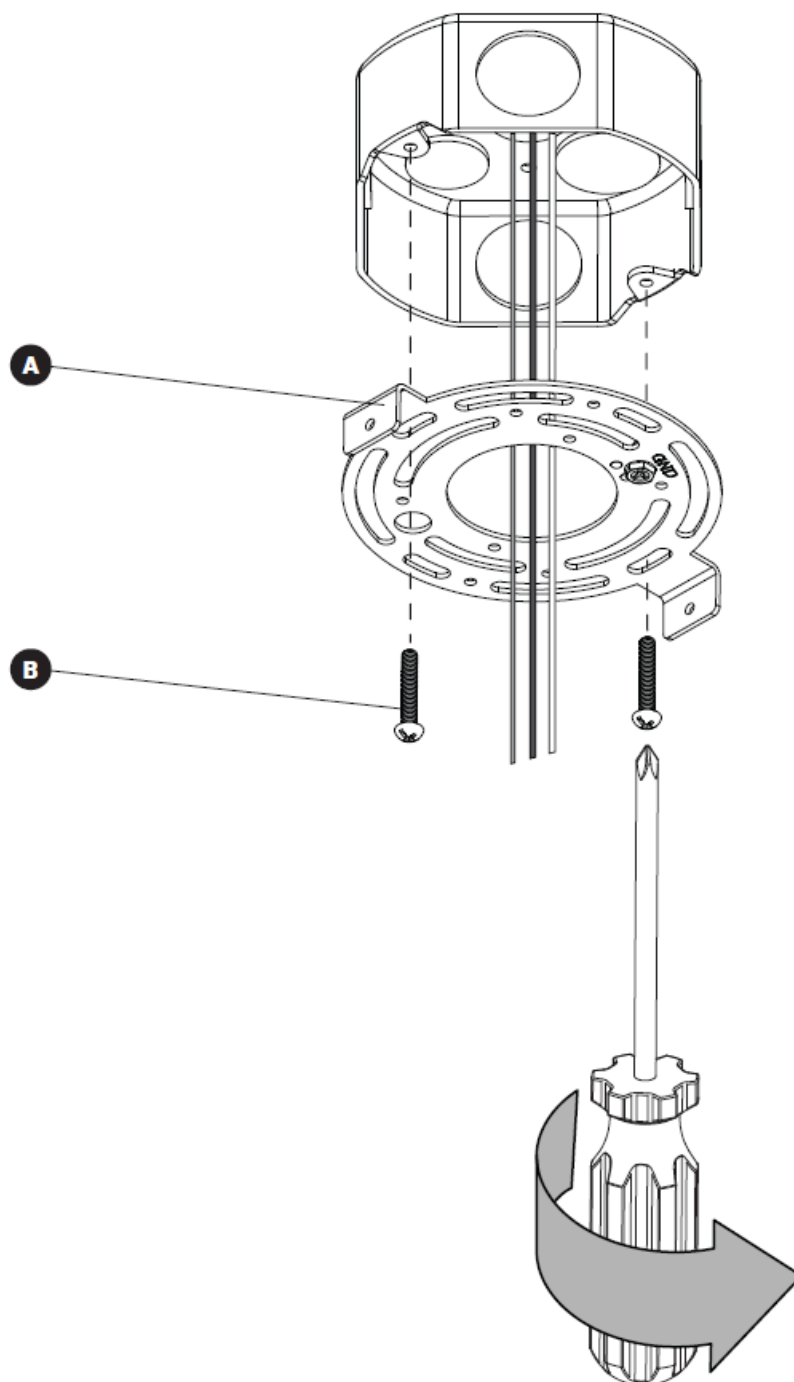

- If using a dimmer, it must be LED-compatible.

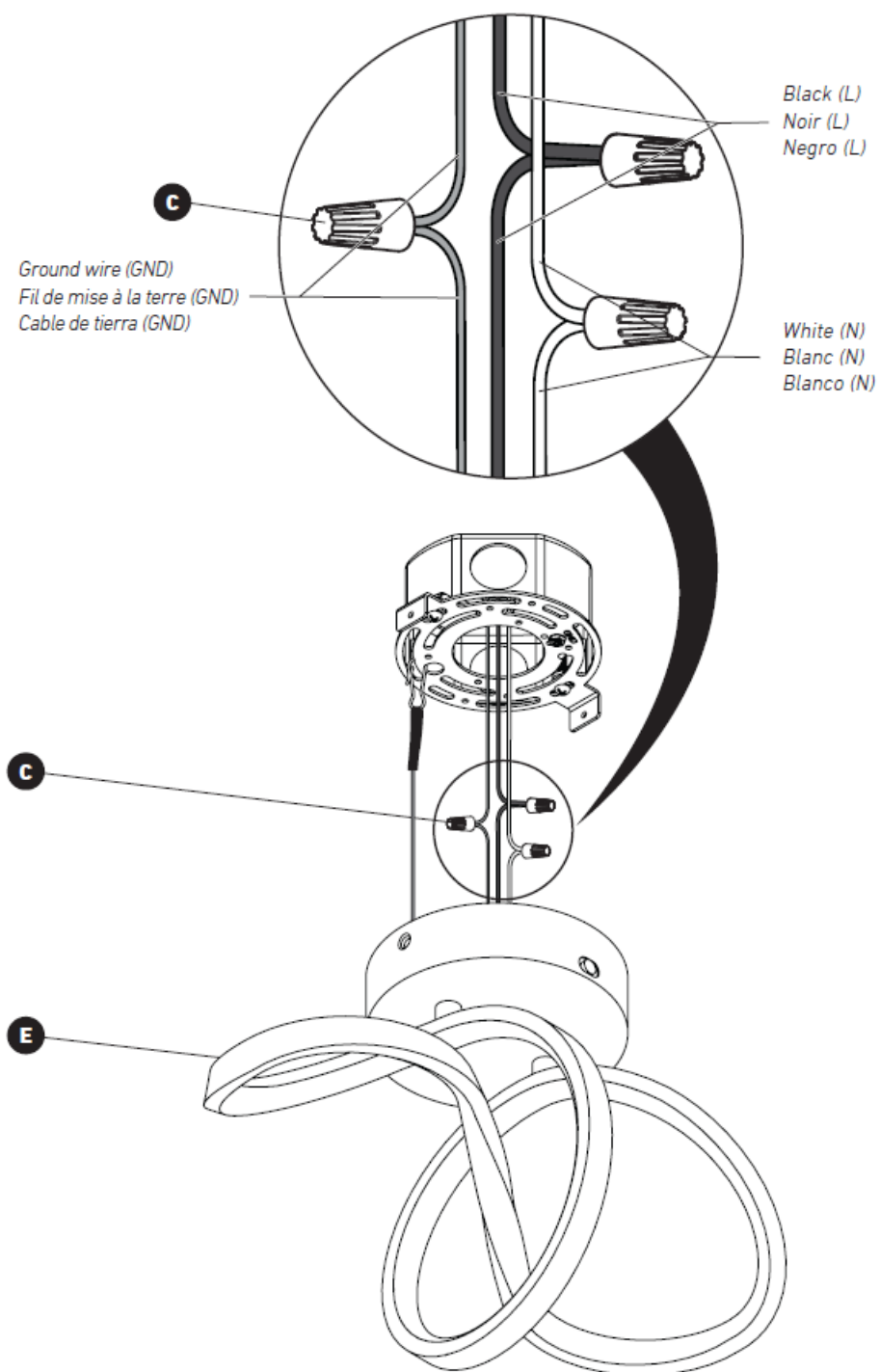

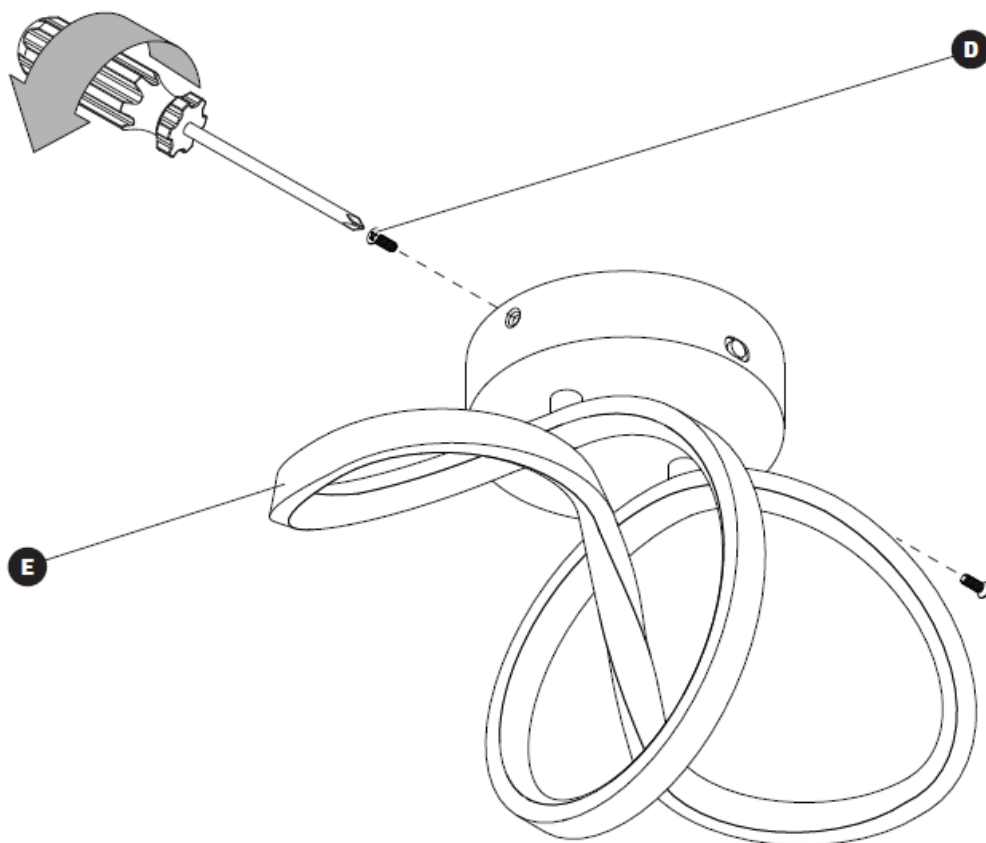

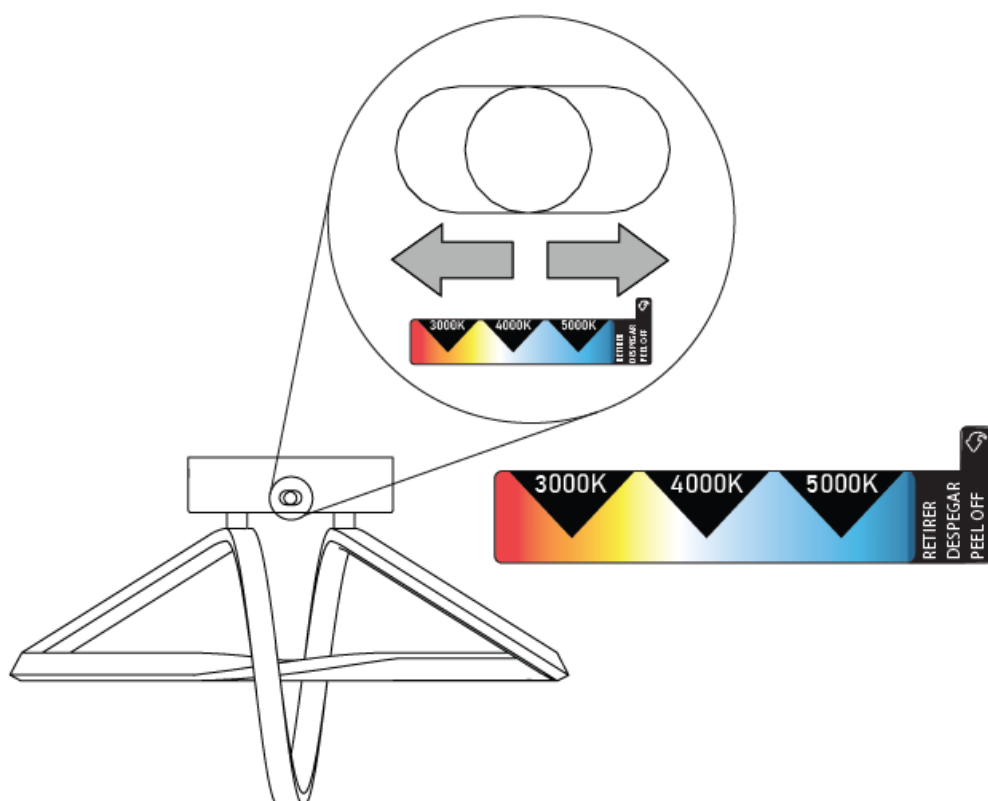
