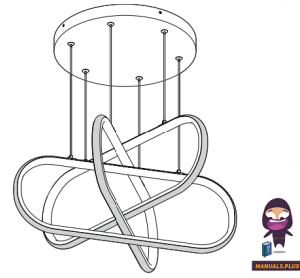

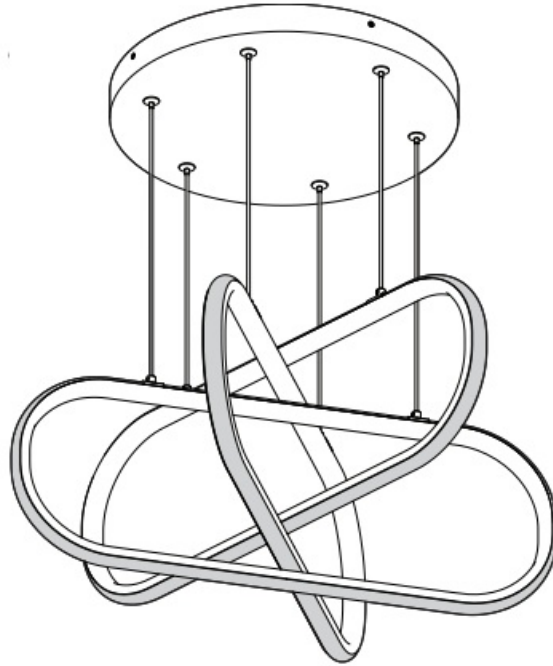

The LED pendant light – Lewis™ is a modern and stylish lighting fixture designed for indoor use. It comes with a mounting bracket, wire connectors, canopy screw, and all necessary installation hardware.

Product Usage Instructions

Installation:

1. Ensure the main electrical supply is switched off before installation.
2. Install the mounting bracket securely using the provided screws.
3. Make wire connections following the color coding (Black – L, White – N).
4. Adjust the height of the light fixture as needed by retracting or extending the wire.
5. Peel off any protective layers before use.

Important Notes:

- If using a dimmer, ensure it is LED-compatible.
- Installation must be done by a certified electrician in compliance with local electrical codes.
- Avoid outdoor use to prevent electrical hazards.

Selectable White Technology:

This feature allows you to adjust the color temperature of the light output according to your preference.

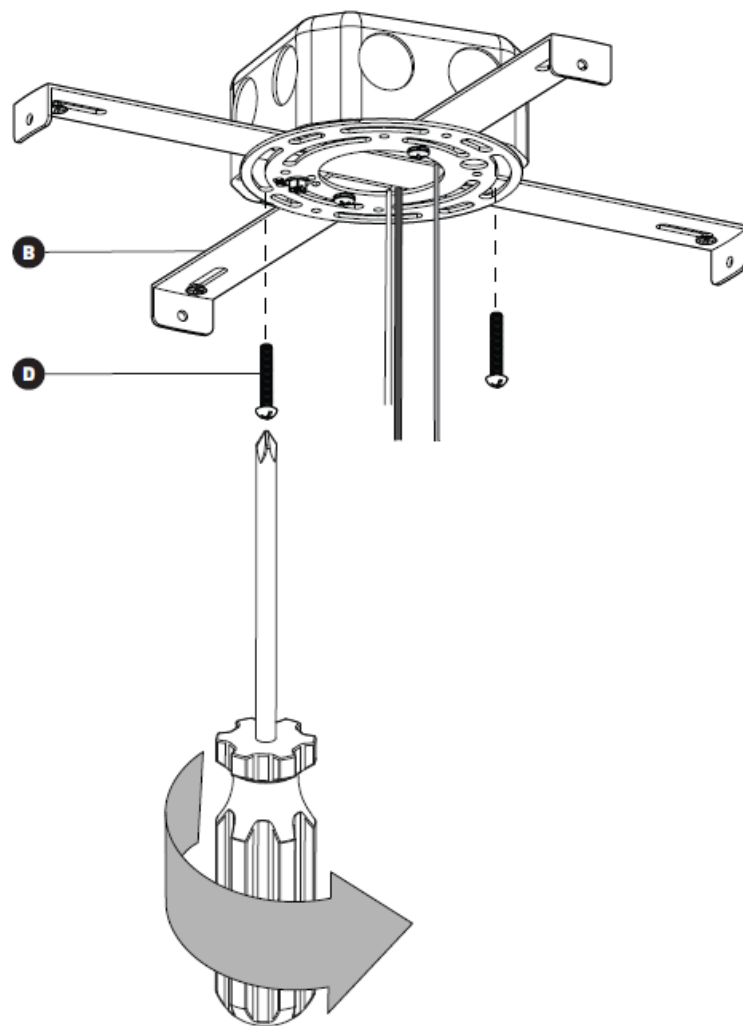


MOUNTING BRACKET MARKING

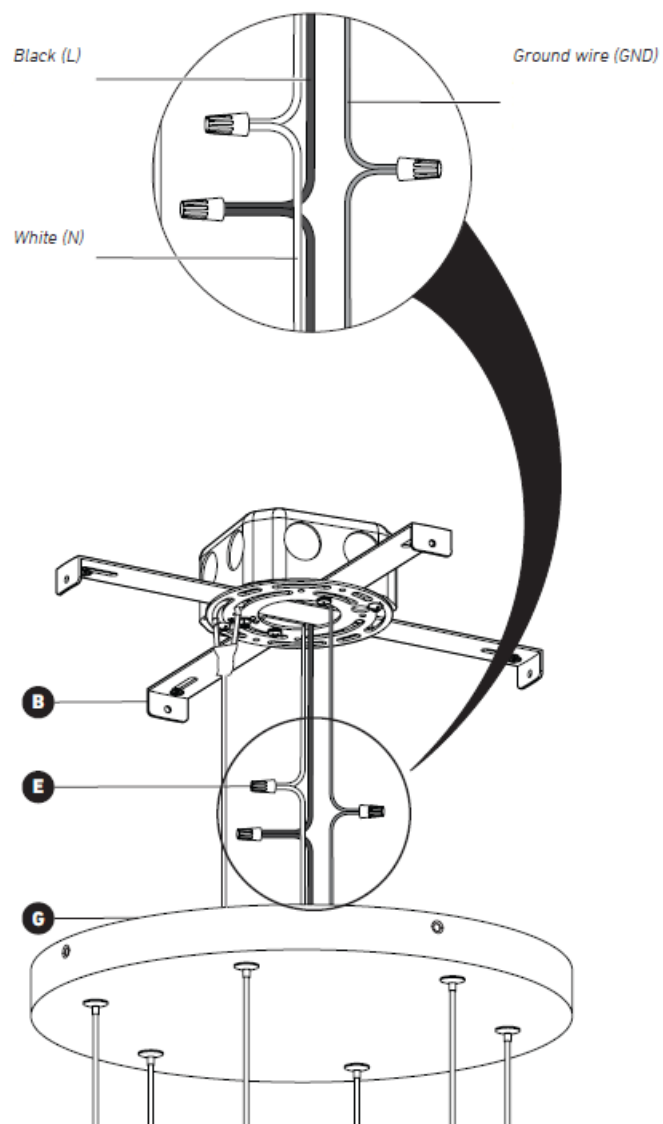


MOUNTING BRACKET INSTALLATION

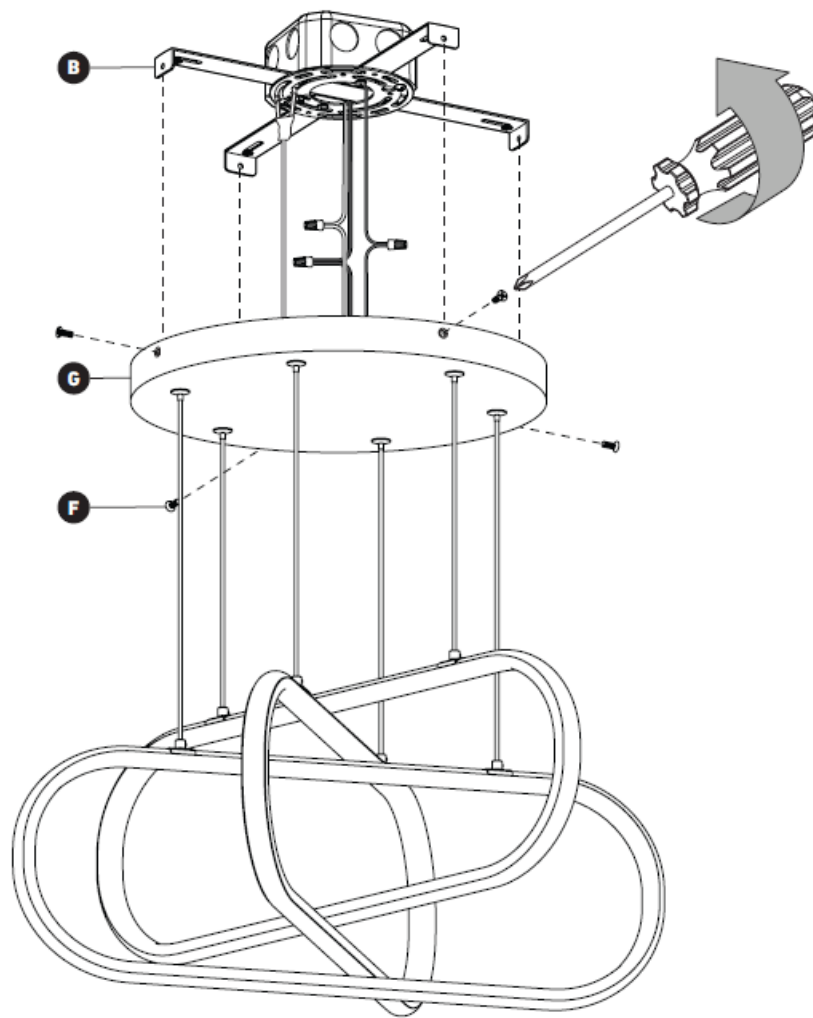




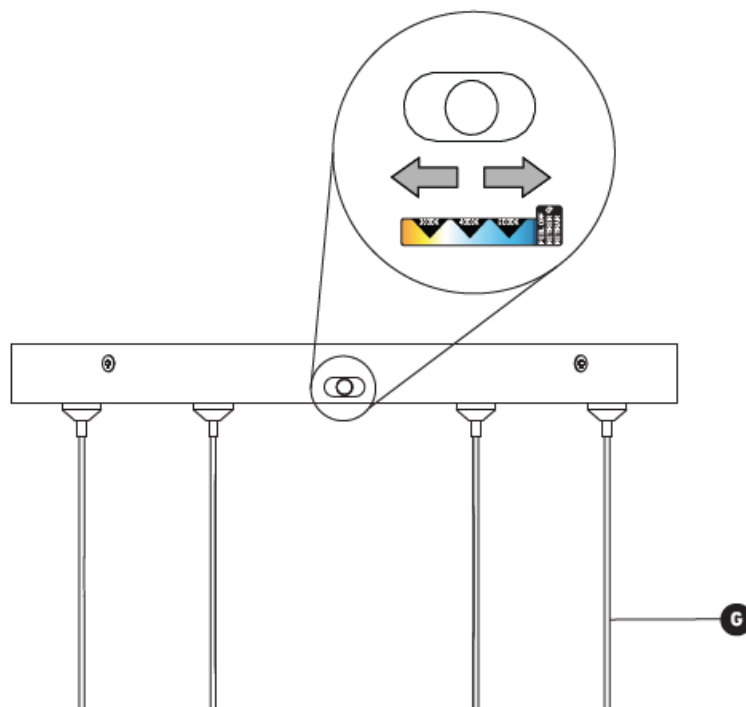
WIRE CONNECTION
