1. INTRODUCTION

This manual provides essential instructions for the safe and effective use of the Bissell Wash & Protect Pro Formula carpet cleaner solution, Model 1089E. This concentrated formula is designed for use with all leading upright carpet cleaners to clean carpets and upholstery, offering professional strength to remove tough stains and odors while providing Scotchgard protection against future stains.

Please read all instructions carefully before using the product.

2. SAFETY INFORMATION

Always prioritize safety when handling cleaning solutions. Adhere to the following guidelines:

- **WARNING:** Causes serious eye irritation.
- **IF IN EYES:** Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

Follow deep cleaning user guide.

Repeat as needed • Rinse & dry cap before returning to bottle.

3. PRODUCT FEATURES

The Bissell Wash & Protect Pro Formula is engineered with several key features to enhance your carpet cleaning experience:

- **Scotchgard Protection:** Contains Scotchgard to help protect your carpets and upholstery from future stains, making subsequent cleaning easier.
- **Universal Compatibility:** Safe for use in all full-sized upright carpet cleaners.
- **2x Concentrated Formula:** A highly concentrated solution, requiring less product per use for effective cleaning.
- **Fresh Fragrance:** Leaves behind a pleasant, fresh scent after cleaning.
- **Earth Friendly Formula:** Designed with environmental considerations.

4. SETUP AND PREPARATION

Before using the Bissell Wash & Protect Pro Formula, ensure proper preparation:

1. **Vacuum Area:** Thoroughly vacuum the carpet or upholstery to remove loose dirt and debris.
2. **Test for Colorfastness:** Always test a small, hidden area of the carpet or upholstery for colorfastness before full application. Apply a small amount of diluted solution to an inconspicuous spot, wait a few minutes, then blot with a white cloth. If color transfers, do not use the product on that material.
3. **Fabric Compatibility:** Do not use on velvet, silk, or other delicate fabrics that may be damaged by water-based cleaning solutions.
4. **Dilution:** Refer to the 'Operating Instructions' section for specific dilution ratios based on soil level.

5. OPERATING INSTRUCTIONS

Follow these steps for effective cleaning with your upright carpet cleaner:

- 1. Dilute the Formula:**
 - **For Light Soil:** Add 1 capful of formula to 2 to 3 gallons of water.
 - **For Extreme Soil:** Add 2 capfuls of formula to 2 to 3 gallons of water.
- 2. Fill Cleaner Tank:** Pour the diluted solution into the clean water tank of your upright carpet cleaner, following your machine's specific instructions for filling.
- 3. Clean Carpet/Upholstery:** Operate your carpet cleaner according to its manufacturer's instructions. Typically, this involves making wet passes (spraying solution) and dry passes (suctioning water) over the area.
- 4. Repeat as Needed:** For heavily soiled areas or stubborn stains, repeat the cleaning process.
- 5. Rinse and Dry:** After cleaning, rinse and dry the carpet or upholstery according to your machine's

instructions to remove any remaining solution and moisture.

6. MAINTENANCE AND STORAGE

Proper care and storage will ensure the longevity and effectiveness of your cleaning solution:

- **Storage:** Store the Bissell Wash & Protect Pro Formula bottle upright in its original container, in a cool, dry place, away from direct sunlight and freezing temperatures.
- **Cap Security:** Ensure the cap is tightly sealed after each use to prevent evaporation or spills.
- **Spill Cleanup:** In case of spills, wipe up immediately with a damp cloth.

7. TROUBLESHOOTING

If you encounter issues during cleaning, consider the following:

- **Poor Cleaning Results:** Ensure correct dilution ratio. For tougher stains, consider a second pass or pre-treating the area. Verify your carpet cleaner is functioning correctly and its tanks are properly filled/emptied.
- **Excessive Foaming:** If your carpet cleaner produces too much foam, you may have used too much solution or not rinsed adequately. Reduce the amount of formula used or perform additional rinse cycles.
- **Residue:** If a sticky residue remains, it may indicate insufficient rinsing. Perform additional rinse cycles with clean water only.
