## SETUP


These note pads require minimal setup. Simply remove the desired number of pads from the packaging. Each pad is ready for immediate use upon removal.

## OPERATING INSTRUCTIONS

Using the Amazon Basics note pads is straightforward:

1. **Writing:** Use any standard writing instrument (pen, pencil, marker) on the wide-ruled lines. The 11/32 inch spacing provides ample room for clear writing.
2. **Page Removal:** To remove a sheet, gently pull it upwards from the perforated top edge of the pad. The perforations are designed for clean tears without messy ripping.
3. **Note Organization:** Utilize the left-side margin and title space at the top of each page for organizing notes, dates, or subject headings.



## MAINTENANCE

To ensure the longevity and quality of your note pads:

- Store in a dry environment to prevent moisture damage to the paper.
- Keep away from direct sunlight or extreme temperatures to avoid paper discoloration or warping of the chipboard backing.
- Avoid bending or creasing the pads excessively to maintain their flat, usable surface.


## TROUBLESHOOTING

While these note pads are designed for reliability, here are solutions to common minor issues:

- **Pages do not tear off cleanly:** If a page does not tear perfectly along the perforation, try tearing slowly and evenly. Ensure the pad is on a flat surface for better leverage.
- **Ink bleed-through:** The paper is suitable for most pens. If using heavy ink markers or fountain pens, test on a small corner or scrap piece first to check for bleed-through, as paper thickness can vary slightly.


