INTRODUCTION

ASSEMBLY INSTRUCTIONS

Follow the step-by-step visual guide provided in the physical instruction booklet included with your playset.

The general assembly process involves:

1. **Base Construction:** Begin by assembling the base of the Chair-O-Matic, ensuring the wobbly spring mechanism is correctly installed.
2. **Chair Assembly:** Construct the massage chair structure, attaching it securely to the spring base.
3. **Sign Assembly:** Build the "Try Me" arrow sign and attach it to the designated spot on the playset.
4. **Minion Figure:** Assemble the undercover Minion figure. Customize its appearance using the removable hat, tie, mustache, and interchangeable parts.
5. **Final Placement:** Place the assembled Minion figure onto the Chair-O-Matic.

OPERATING INSTRUCTIONS

Once assembled, the Chair-O-Matic Playset offers interactive play features:

- **Wobbly Chair:** Gently push or tap the massage chair to activate its wobbly spring base, simulating movement.

- **Minion Customization:** Change the Minion's appearance by swapping its hat, tie, mustache, and other body parts to create different looks.
- **Interactive Sign:** The "Try Me" sign is a static display element, inviting imaginative play scenarios.

MAINTENANCE

To keep your playset in good condition:

- **Cleaning:** Wipe parts with a soft, damp cloth. Do not use harsh chemicals or abrasive cleaners.
- **Storage:** Store the playset in a cool, dry place away from direct sunlight to prevent discoloration or warping of plastic parts.
- **Inspection:** Periodically check for any loose or damaged parts. Replace damaged parts if necessary.

TROUBLESHOOTING

- **Missing Pieces:** If you find any pieces missing upon opening the box, please contact Mega Bloks customer support.
- **Difficulty Assembling:** Double-check the physical instruction booklet. Ensure pieces are oriented correctly and sufficient force is applied for connection.
