ELRO ADS1F Dummy Alarm Siren User Manual

1. PRODUCT OVERVIEW

The ELRO ADS1F Dummy Alarm Siren is designed to deter potential intruders by mimicking the appearance and function of a real alarm siren. It serves as a preventive measure without requiring an extensive security system. This dummy siren features a red LED lamp that flashes to simulate an active alarm, enhancing its deterrent effect, especially at night.

Key features include:

- Simple, cost-effective, and sustainable theft and vandalism prevention.
- Realistic appearance of an active alarm siren.
- Quick and straightforward installation.

4. SETUP AND INSTALLATION

The ELRO ADS1F Dummy Alarm Siren is designed for quick and easy installation. Follow these steps to mount the unit:

- 1. Choose a Location:** Select a visible location on the exterior of your home or property, preferably at a height that makes it difficult to reach but easy to see. Ensure the location is suitable for wall mounting.
- 2. Insert Batteries:** Open the front cover of the dummy siren. Insert the three 1.5V AA batteries into the designated battery compartment. Ensure correct polarity. Close the cover securely.
- 3. Mark Drilling Points:** Hold the dummy siren against the chosen wall location. Use a pencil to mark the positions for the mounting screws through the pre-drilled holes on the back plate of the unit.
- 4. Drill Holes:** Using an appropriate drill bit for your wall type, drill holes at the marked positions. Insert the provided wall plugs into the drilled holes.
- 5. Mount the Siren:** Align the dummy siren with the drilled holes and secure it to the wall using the provided screws. Tighten the screws until the unit is firmly attached to the wall.

6. **Apply Security Sticker:** Place the included security sticker in a prominent location, such as a window or door, to further enhance the deterrent effect.

5. OPERATING INSTRUCTIONS

The ELRO ADS1F Dummy Alarm Siren operates automatically once batteries are installed. Its primary function is to provide a visual deterrent:

- **Flashing LED:** The integrated red LED light will begin to flash periodically once the batteries are correctly inserted. This flashing light simulates the activity of a live alarm system, making the dummy siren appear functional and active, especially during nighttime hours.
- **Continuous Operation:** The device is designed for continuous operation as long as the batteries provide power. There are no on/off switches or complex controls.

No further user interaction is required for its operation beyond initial battery installation and mounting.

6. MAINTENANCE

The ELRO ADS1F Dummy Alarm Siren requires minimal maintenance to ensure its continued effectiveness:

- **Battery Replacement:** The flashing LED light will dim or cease operation when the batteries are low. Replace all three AA batteries with new ones when this occurs to maintain the deterrent effect.
- **Cleaning:** Periodically wipe the exterior of the unit with a soft, damp cloth to remove dust, dirt, or cobwebs. Do not use abrasive cleaners or solvents.
- **Inspection:** Occasionally inspect the mounting screws to ensure the unit remains securely attached to the wall. Check for any visible damage to the casing.

Ensure the battery compartment is always sealed to protect against moisture and environmental elements.

7. TROUBLESHOOTING

If you encounter issues with your ELRO ADS1F Dummy Alarm Siren, consider the following:

- **LED Not Flashing:**
 - Check if the batteries are inserted correctly, observing polarity (+/-).
 - Replace the batteries with new 1.5V AA batteries.
 - Ensure the battery compartment cover is fully closed.
- **Unit Feels Loose on Wall:**
 - Carefully re-tighten the mounting screws.
 - If the wall plugs are loose, consider using larger wall plugs or relocating the unit slightly.
- **Visible Damage:**
 - If the unit is physically damaged, its effectiveness as a deterrent may be compromised. Consider replacement.

For issues not resolved by these steps, please refer to the support section.

8. WARRANTY INFORMATION

ELRO provides a **2-year warranty** on the ADS1F Dummy Alarm Siren. This warranty covers defects in materials and workmanship under normal use. It does not cover damage resulting from misuse, accidents, unauthorized modifications, or improper installation.
