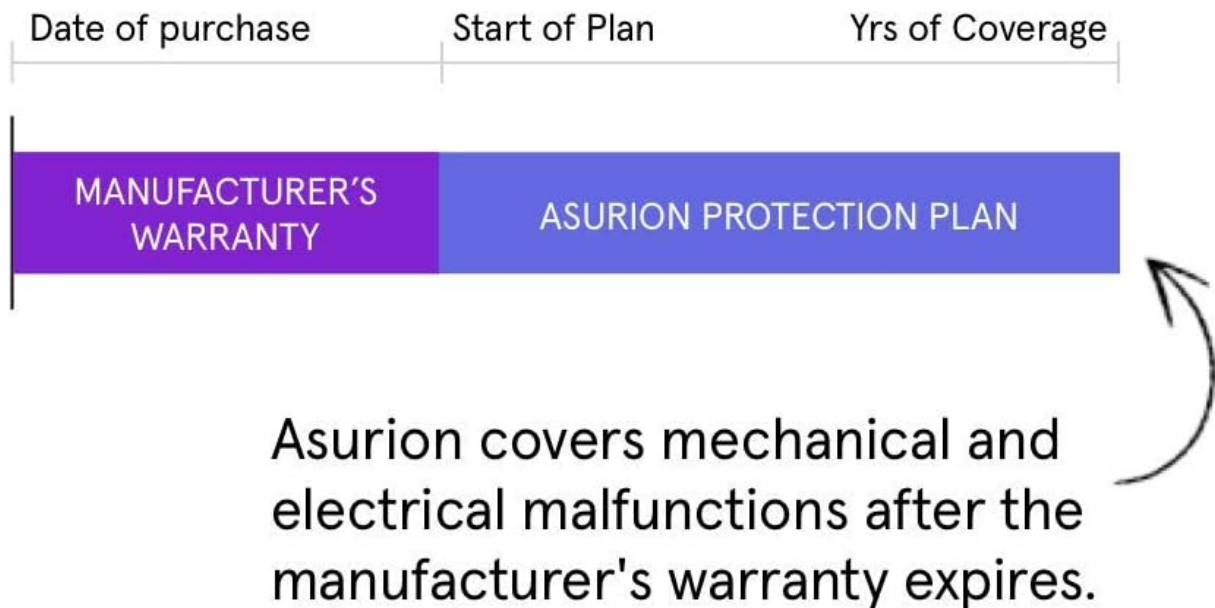
## How the Plan Works
