1. PRODUCT OVERVIEW

The Sauder Hudson Court Floating Wall-Mounted Night Stand is designed to provide convenient bedside storage while optimizing space. This wall-mounted unit offers a surface for essential items and a storage trough for books, electronics, and other small articles. It features a cord management system to maintain a tidy appearance. The unit is finished in Charcoal Ash with Pearl Oak accents and includes chamfered edges for a refined look.

2. SETUP AND ASSEMBLY

This product requires assembly. All necessary materials, hardware, and detailed assembly instructions are included in the packaging. It is recommended to assemble the unit in the room where it will be installed. Ensure all parts are present before beginning assembly.

2.1 Unpacking and Part Identification

- Carefully unpack all components from the box.
- Lay out all parts on a clean, soft surface to prevent scratches.
- Refer to the included parts list and hardware diagram to identify each component.

2.2 Assembly Steps

1. Follow the step-by-step instructions provided in the assembly manual included with your product.
2. Use only the provided hardware. Do not overtighten screws.
3. Once assembled, carefully lift and position the unit against the desired wall.
4. Securely mount the nightstand to the wall using appropriate hardware for your wall type (e.g., wall anchors for drywall, screws into studs). Ensure it is level and stable before placing items on it.

3. OPERATION AND FEATURES

3.1 Surface Space

The top surface provides ample space for items such as an alarm clock, a lamp, a glass of water, or decorative accents. The maximum recommended weight for the surface is 10 pounds.

3.2 Storage Trough

The integrated storage trough is ideal for keeping items like books, reading glasses, tablets, or other small personal belongings easily accessible yet neatly organized. This area helps reduce clutter on the main surface.

3.3 Cord Management System

A dedicated cord management system is incorporated to allow electrical cords from devices (such as smartphones or lamps) to pass through discreetly, keeping wires neat and out of sight.

4. MAINTENANCE AND CARE

- **Cleaning:** Wipe the surface with a dry cloth to remove dust and light smudges. Avoid using abrasive cleaners, harsh chemicals, or excessive moisture, as these can damage the finish.
- **Spills:** Immediately wipe up any spills with a dry cloth to prevent moisture absorption and staining.
- **Sunlight:** Avoid prolonged exposure to direct sunlight, which can cause fading or discoloration over time.
- **Heat:** Do not place hot items directly on the surface. Use coasters or protective pads.

5. TROUBLESHOOTING

This section addresses common issues you might encounter with your nightstand.

5.1 Stability Issues

- **Issue:** The nightstand feels wobbly or unstable after mounting.
- **Solution:** Ensure all wall mounting hardware is securely fastened to the wall studs or appropriate anchors. Verify that the unit is level. If necessary, re-mount the unit, ensuring proper installation techniques are followed.

5.2 Surface Damage

- **Issue:** Scratches or minor dents on the surface.
- **Solution:** For minor scratches, furniture repair markers or touch-up pens matching the finish color may be used. For deeper damage, professional repair might be necessary. Always use protective pads under items that could scratch the surface.

5.3 Missing or Damaged Parts

- **Issue:** Parts are missing or damaged upon unboxing.
- **Solution:** Do not proceed with assembly. Contact Sauder customer support immediately with your product model number (425815) and a description of the missing or damaged parts.
