## SAFETY INFORMATION

## **SETUP INSTRUCTIONS**

- 1. **Unpacking:** Carefully remove the power controller from its packaging. Inspect the unit for any signs of damage.
- 2. **Placement:** Place the power controller on a stable, dry surface, away from direct water contact. Ensure adequate ventilation around the unit.

#### 3. Connecting Devices:

- Connect your pedicure spa's jet pump and LED lights to the switched on/off ports. These ports are controlled by the main power switch.
- Connect your massage chair or other continuous power devices to the continuous port (CONT 2A).
   This port provides constant power when the unit is plugged in.
- Connect your drain pump to the dedicated drain pump control port (DRAIN 1.5A). This port features

# **OPERATING INSTRUCTIONS**

- 1. **Powering On:** Once all devices are connected, plug the main power cord of the controller into a wall outlet. The continuous port will immediately receive power.
- 2. **Operating Switched Ports:** Use the main power switch on the controller to turn on/off devices connected to the switched ports (e.g., jet pump, LED lights).
- 3. **Using the Drain Pump Timer:** To activate the drain pump, press the button associated with the drain pump control port. The pump will operate for approximately 3 minutes and then automatically shut off. This timed feature prevents accidental overflow and conserves energy.

# MAINTENANCE

To ensure the longevity and proper functioning of your Luraco Pedicure Spa Power Controller, follow these simple maintenance guidelines:

- Inspection: Periodically inspect the power cord and all connected cables for any signs of wear, fraying, or

damage. If any damage is found, discontinue use and contact customer support.

• **Storage:** When not in use for extended periods, store the power controller in a cool, dry place, away from direct sunlight and extreme temperatures.

# **TROUBLESHOOTING**

If you encounter issues with your power controller, please refer to the following common troubleshooting steps:

#### • No Power:

- Ensure the power controller's main plug is securely inserted into a working electrical outlet.
- Check if the outlet itself is receiving power by plugging in another device.
- Verify that the main power switch on the controller is in the "ON" position for switched ports.

#### • Drain Pump Not Activating:

- Confirm the drain pump is correctly plugged into the designated "DRAIN" port.
- · Press the drain pump activation button firmly.
- Check the drain pump itself for any blockages or malfunctions.

#### • Devices Not Functioning on Switched Ports:

- Ensure the devices are properly connected to the switched ports.
- Verify that the main power switch on the controller is engaged.
- Test the individual devices by plugging them directly into a wall outlet to rule out device malfunction.
