1. PRODUCT OVERVIEW

2. SETUP AND DECK INTEGRATION

Card Abilities:

- **Ability 3 (Self-destruction Condition):** *"Effective Normal Square: If your opponent has no cards in their Square or if your Square is empty, destroy this card."* This condition indicates that the card requires specific board states to remain in play, suggesting a strategic element to its deployment and maintenance.

Players should refer to the official Z/X rulebook for detailed explanations of game terms such as "Square," "Charge," "Trash," "Cost," and "Guardian" tokens to fully understand and utilize this card's effects.

4. MAINTENANCE AND CARE

Proper care ensures the longevity and pristine condition of your Z/X B39-101 Dazzling Infinite Vow Gear Bowstring Feather Misaki card, preserving its value and playability.

Handling and Storage:

- Sleevng:** It is highly recommended to place the card in a protective card sleeve immediately after acquisition to prevent scratches, bends, and surface wear.



