3. GETTING STARTED (SETUP)

3.1 Charging the Smart Watch

Before first use, fully charge your Blackview W60. The watch features a 900mAh battery, providing up to 100 days of standby time and 30 days of typical usage. Use the provided magnetic charging cable.

1. Connect the USB end of the charging cable to a power adapter (5V/1A recommended) or a computer USB port.
2. Align the magnetic end of the cable with the charging contacts on the back of the watch. It will snap into place.
3. The watch screen will indicate charging status. A full charge typically takes approximately 2.5 hours.

3.2 App Installation and Pairing

To unlock the full potential of your smartwatch, download and install the **GloryFitPro** app on your smartphone.

1. Scan the QR code in the product manual or search for 'GloryFitPro' in your smartphone's app store (compatible with Android 6.0+ and iOS 9.0+).
2. Open the GloryFitPro app and follow the on-screen instructions to create an account and set up your personal profile.
3. In the app, navigate to 'Device' or 'Add Device' and select your Blackview W60 from the list of available devices. Ensure Bluetooth is enabled on your phone.
4. Confirm the pairing request on both your phone and the watch.

3.3 Attaching/Changing Watch Straps

Your Blackview W60 comes with two comfortable and skin-friendly wristbands: a silicone strap and a nylon strap. You can easily interchange them to suit your preference or activity.

- To attach a strap: Slide the spring bar of the strap into the lug holes on the watch body until it clicks into place.
- To detach a strap: Locate the small lever on the spring bar, pull it inwards, and gently slide the strap out of the lug.

4. OPERATING INSTRUCTIONS

4.1 Basic Navigation

The Blackview W60 features a 2.01-inch HD full touch screen and physical buttons for navigation.

- **Touch Screen:** Swipe left/right to switch between main functions, swipe up/down to access quick settings or notifications. Tap to select.
- **Side Buttons:** Use the 'MENU' button to access the main menu and the 'BACK' button to return to the previous screen or watch face.

4.2 Call Answering/Making

With its built-in HiFi stereo speakers and microphone, you can manage calls directly from your watch when connected via Bluetooth.

- **Answering Calls:** When an incoming call rings, tap the green phone icon on the watch screen to answer.
- **Making Calls:** Access the dial pad or contact list on your watch to initiate a call. The GloryFitPro app allows you to store multiple contacts for quick access.

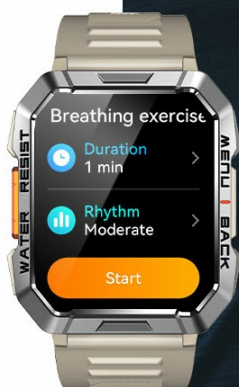


Figure 4: Call Management on Your Smartwatch

- Historical data and detailed analysis are available in the GloryFitPro app.

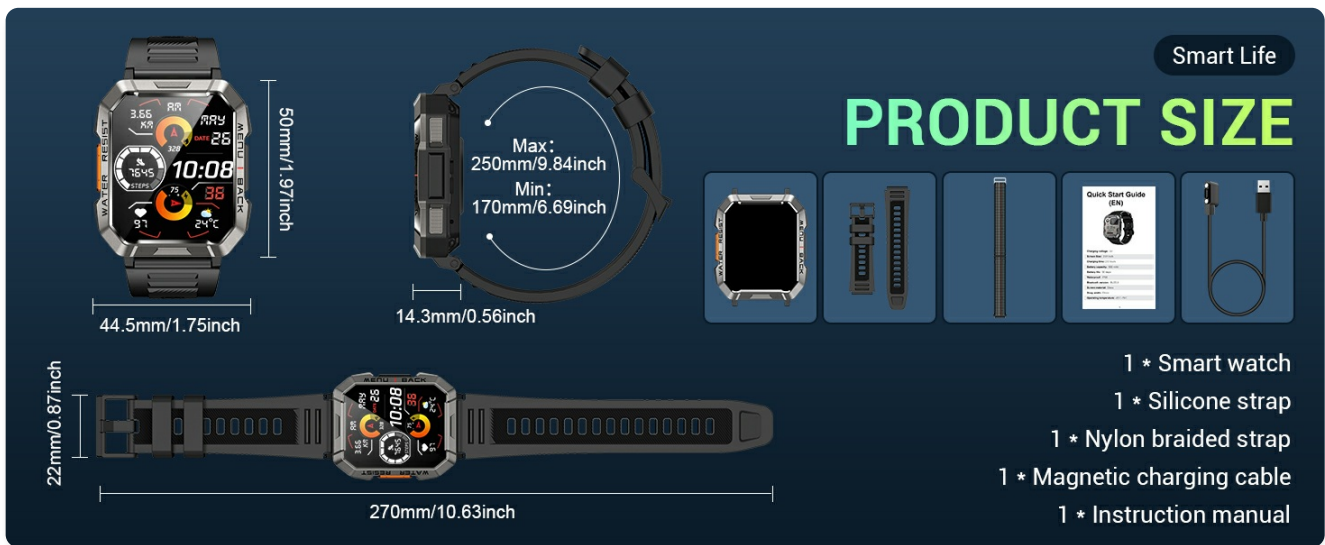


Figure 10: 24H Heart Rate Monitoring

- Ensure the watch is worn snugly on your wrist for accurate readings.

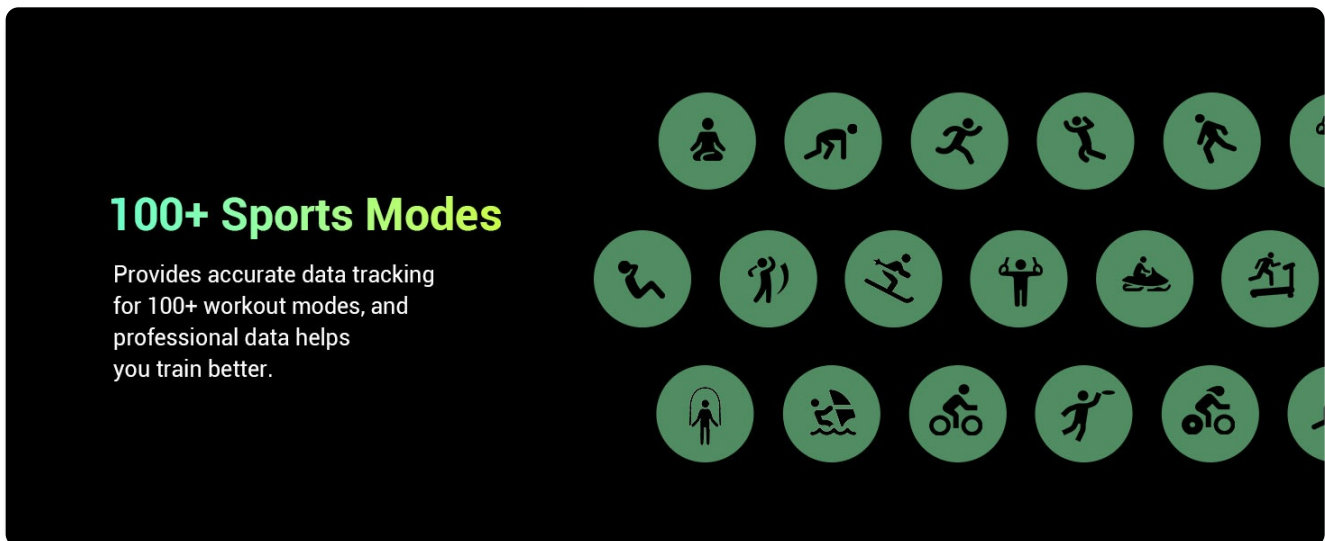


Figure 11: SpO2 Saturation Monitoring

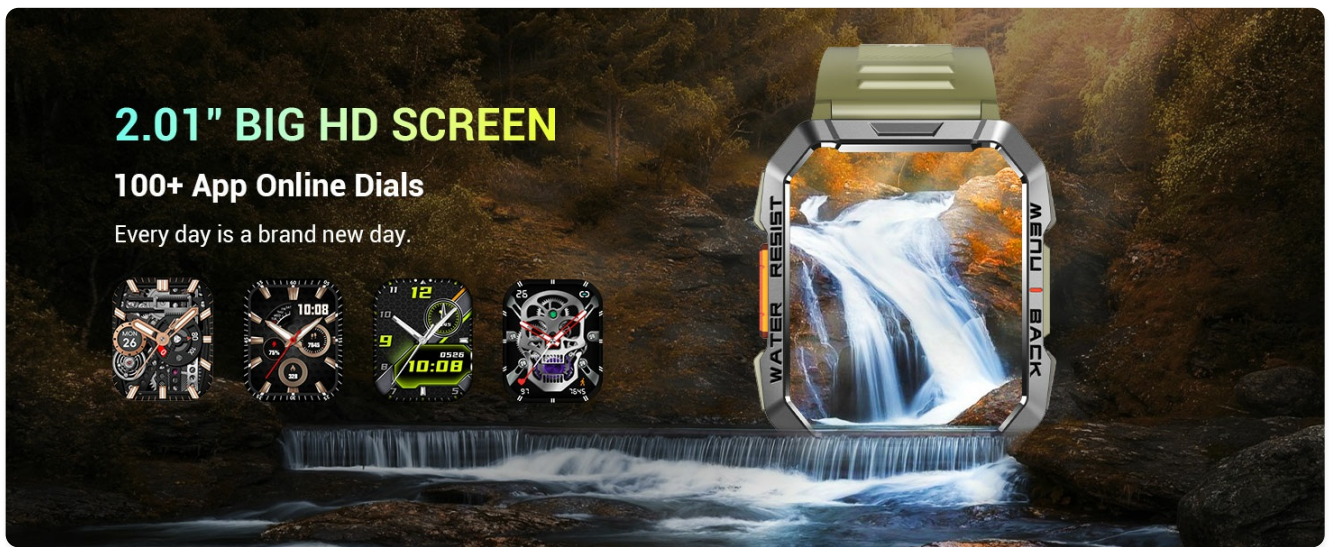


Figure 13: Breathing Exercises to Relax Body

7. MAINTENANCE

To ensure the longevity and optimal performance of your Blackview W60, follow these maintenance guidelines:

- **Cleaning:** Regularly wipe the watch screen and straps with a soft, dry cloth. For stubborn dirt, use a slightly damp cloth and then dry thoroughly.
- **Water Resistance:** The watch is IP68 waterproof, suitable for daily use like hand washing or rain. **NOTE:** It is not suitable for sauna, hot water, swimming, or diving. Avoid prolonged exposure to water.
- **Storage:** Store the watch in a cool, dry place when not in use. Avoid extreme temperatures.
- **Charging:** Use only the provided magnetic charging cable. Do not use damaged cables or chargers.

8. TROUBLESHOOTING

If you encounter issues with your Blackview W60, please refer to the following common solutions:

Problem	Possible Cause	Solution
Watch not turning on	Low battery; device frozen	Charge the watch for at least 30 minutes. If still unresponsive, press and hold the power button for 10-15 seconds to force restart.
Cannot pair with phone	Bluetooth off; app issue; watch not discoverable	Ensure Bluetooth is on for both devices. Restart both the watch and phone. Reinstall the GloryFitPro app. Ensure the watch is in pairing mode.
Inaccurate health data	Improper fit; sensor obstruction	Ensure the watch is worn snugly on your wrist, one finger's width above the wrist bone. Keep the sensor clean and free from debris.
Notifications not received	App permissions; app not running in background	Check notification permissions for GloryFitPro in your phone settings. Ensure the app is running in the background and not optimized for battery saving.
