Leitz IQ OptiMax Office P5 Micro Shredder User Manual

1. INTRODUCTION

This manual provides essential information for the safe and efficient operation, maintenance, and troubleshooting of your Leitz IQ OptiMax Office P5 Micro Shredder. Please read this manual thoroughly before using the shredder and retain it for future reference.

2. SAFETY INFORMATION

Always follow basic safety precautions when using this appliance to reduce the risk of fire, electric shock, or injury.

- Keep fingers, loose clothing, hair, and jewelry away from the paper entry slot.
- Unplug the shredder before moving, cleaning, or emptying the waste bin.
- Do not allow children or pets near the shredder.
- Do not shred metal objects, large paper clips, or adhesive labels.
- Do not use aerosol cleaners or lubricants on the shredder.
- Ensure the shredder is placed on a stable, level surface.

3. WHAT'S IN THE BOX

Upon unpacking, please verify that all components are present:

- Leitz IQ OptiMax Office P5 Micro Shredder Unit

- Waste Bin (35L capacity)
- User Manual (this document)

4. SETUP

1. **Unpacking:** Carefully remove the shredder from its packaging.
2. **Placement:** Position the shredder on a flat, stable surface near a power outlet. Ensure adequate ventilation around the unit. The circular design allows for space-saving placement.
3. **Bin Installation:** Ensure the 35L waste bin is correctly inserted into the shredder unit. The shredder will not operate if the bin is not properly seated.
4. **Power Connection:** Plug the power cord into a grounded electrical outlet.

5. OPERATING INSTRUCTIONS

5.1 Basic Shredding

1. Ensure the shredder is plugged in and the waste bin is correctly inserted.
2. The LED display will illuminate, indicating readiness.
3. Insert up to 10 sheets of A4 paper (70-80g) into the paper entry slot. The shredder will automatically start shredding.
4. The shredder can also shred staples and small paper clips.
5. The shredder operates quietly, promoting a calm working environment.

5.2 Bin Rotation Technology (BRT)

The unique Bin Rotation Technology (BRT) ensures an even distribution of shredded paper within the 35L bin, increasing its effective capacity by 33% (up to 550 A4 sheets). This technology prevents paper chips from forming a peak, allowing more shredding before the bin needs emptying.

5.3 LED Display Indicators

The intuitive LED display provides important status updates:

- **Full Bin Indicator:** Illuminates when the 35L collection container is full and requires emptying.
- **Open Flap Indicator:** Illuminates if the shredder head or bin is not properly closed.
- **Overheat Indicator:** Illuminates if the shredder has been used continuously for too long and needs to cool down.
- **Jam Indicator:** Illuminates if a paper jam occurs.

6. MAINTENANCE

6.1 Emptying the Waste Bin

When the "collection container full" indicator illuminates, the bin needs to be emptied. Simply pull out the bin from the front of the shredder and dispose of the shredded material. Reinsert the bin firmly until it clicks into place.

6.2 Oiling the Shredder

To maintain optimal performance and extend the life of your shredder, it is recommended to oil the cutting blades regularly, especially after emptying the bin multiple times or after heavy use. Use shredder oil sheets or liquid shredder oil specifically designed for paper shredders. Follow the instructions provided with the shredder oil product.

6.3 Cleaning

Wipe the exterior of the shredder with a soft, dry cloth. Do not use abrasive cleaners or solvents. Ensure the shredder is unplugged before cleaning.

7. TROUBLESHOOTING

Problem	Possible Cause	Solution
Shredder does not turn on.	Not plugged in; waste bin not properly inserted; power switch off.	Ensure power cord is securely plugged in; reinsert waste bin correctly; turn power switch to ON.
Shredder stops during operation.	Overheated; paper jam; waste bin full.	Allow shredder to cool down (approx. 30 minutes); clear paper jam (see below); empty waste bin.
Paper jam.	Too many sheets inserted; paper not fed straight.	Press the reverse button to clear the jam. If unsuccessful, unplug the shredder and carefully remove paper manually.
Shredder is noisy.	Blades need oiling.	Oil the shredder blades as per maintenance instructions.

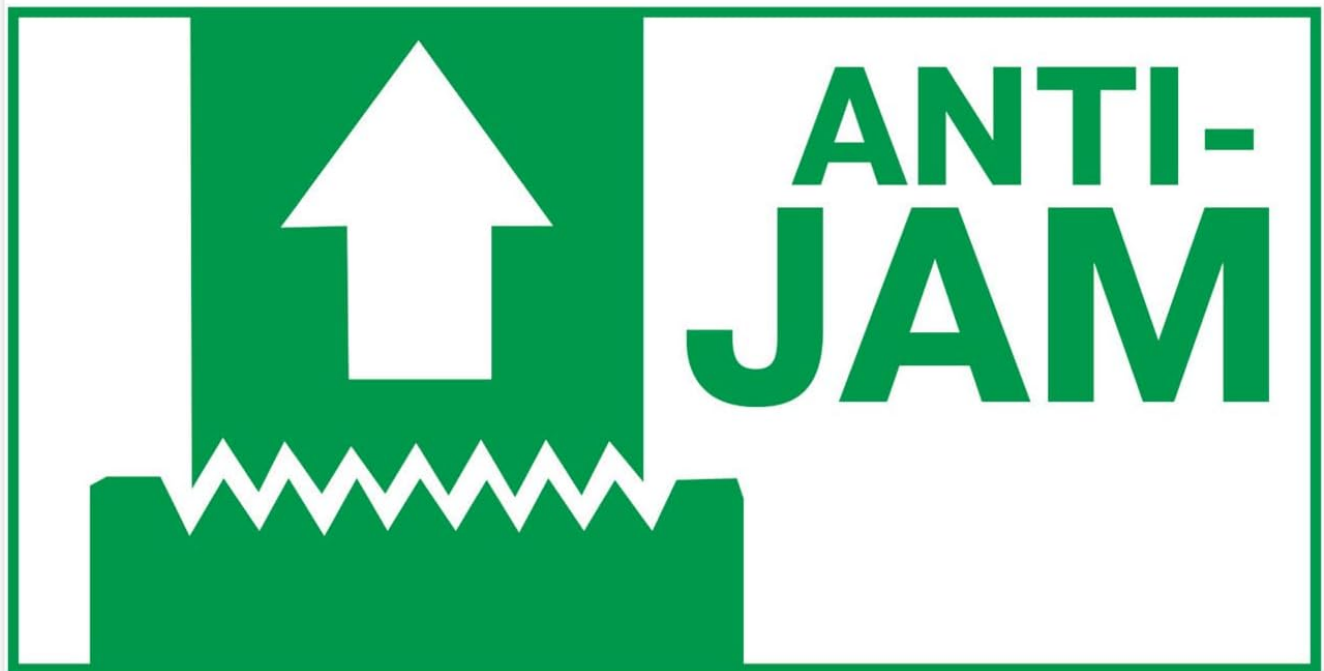


Image 7.1: The Anti-Jam feature logo, indicating the shredder's capability to prevent and resolve paper jams for smoother operation.

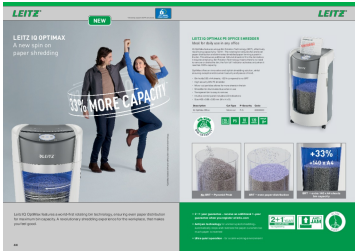
