### **INTRODUCTION**

This manual provides essential information for the safe and effective use of your GN ReSound Desktop Charger. Please read this manual thoroughly before using the device and retain it for future reference.

The GN ReSound Desktop Charger is designed exclusively for charging GN ReSound Key and GN ReSound Quattro Receiver-In-Ear (RIE) hearing aids.

### PRODUCT OVERVIEW

The desktop charger features two dedicated charging ports, one for each hearing aid. It provides a stable and efficient charging solution for compatible ReSound hearing aids.

# **C**OMPATIBILITY

This charger is **ONLY** compatible with the following hearing aid models:

- GN ReSound Key Receiver-In-Ear (RIE) hearing aids
- GN ReSound Quattro Receiver-In-Ear (RIE) hearing aids

Using this charger with incompatible hearing aid models may result in damage to the hearing aids or the charger itself.

### SETUP

# **Unpacking**

Carefully remove all components from the packaging. Ensure the following items are present:

- · GN ReSound Desktop Charger unit
- Power adapter (AC)
- · USB charging cable
- User Manual (this document)

# **Connecting the Charger**

- 1. Connect the USB charging cable to the USB port on the back of the desktop charger.
- 2. Connect the other end of the USB cable to the power adapter.
- 3. Plug the power adapter into a standard electrical outlet.
- 4. The charger is now ready for use.

### **OPERATING INSTRUCTIONS**

# **Charging Hearing Aids**

- 1. Ensure the desktop charger is connected to a power source as described in the "Setup" section.
- 2. Gently insert each compatible hearing aid into its respective charging port on the desktop charger. Ensure they are seated correctly.
- 3. Charging will begin automatically. The indicator lights on the hearing aids (if present) or on the charger itself will typically show the charging status. Refer to your hearing aid's specific manual for details on its charging indicators.
- 4. A full charge typically takes approximately 3 hours.
- 5. Once fully charged, the hearing aids can be removed from the charger.

# **Charging Indicators**

The charger itself does not have external charging indicator lights. The charging status is indicated by the lights on your hearing aids. Please consult your hearing aid's user manual for specific details on its charging light patterns (e.g., solid light for charging, blinking for low battery, green for fully charged).

### MAINTENANCE AND CARE

- Cleaning: Wipe the charger with a soft, dry cloth. Do not use abrasive cleaners, solvents, or immerse the charger in water.
- Storage: Store the charger in a cool, dry place away from direct sunlight and extreme temperatures when not in use.
- Handling: Handle the charger with care. Avoid dropping it or subjecting it to strong impacts.
- Power Supply: Always use the original power adapter and USB cable provided with the charger.

# **TROUBLESHOOTING**

Problem	Possible Cause	Solution
Hearing aids not charging.	Charger not connected to power.  Hearing aids not seated correctly.  Incompatible hearing aid model.  Damaged charger or cable.	Ensure power adapter is plugged into outlet and charger.  Re-insert hearing aids, ensuring a secure connection.  Verify hearing aid model compatibility (GN ReSound Key or Quattro RIE).  Contact customer support if charger or cable appears damaged.

Problem	Possible Cause	Solution
Charging takes longer than 3 hours.	Hearing aids were completely drained.  Environmental factors (e.g., extreme temperature).	This is normal for deeply discharged batteries.  Ensure charging in a room temperature environment.
