- **Weather Resistance:** While the sign is weather-resistant and waterproof, extreme conditions may still affect its appearance over time. Consider sheltered placement for prolonged outdoor exposure to maximize its lifespan.

6. TROUBLESHOOTING

Common issues and their solutions:

| Problem | Solution |
|---|--|
| Sign is not visible or easily readable. | Ensure it's placed at eye level and not obstructed. Improve lighting in the area if necessary. |
| Sign appears loose or unstable. | Re-secure fasteners. Replace damaged fasteners or use more robust mounting hardware if needed. |
| Sign is dirty or text is unclear. | Clean with a soft, damp cloth and mild soap. Avoid abrasive materials. |
