3. Choose the audio you want to play.
4. Adjust volume and settings as needed through the app.

## FAQ

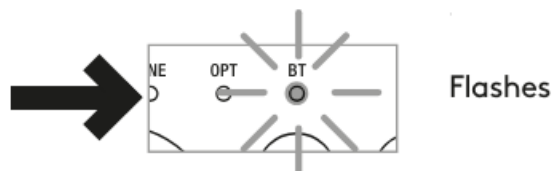

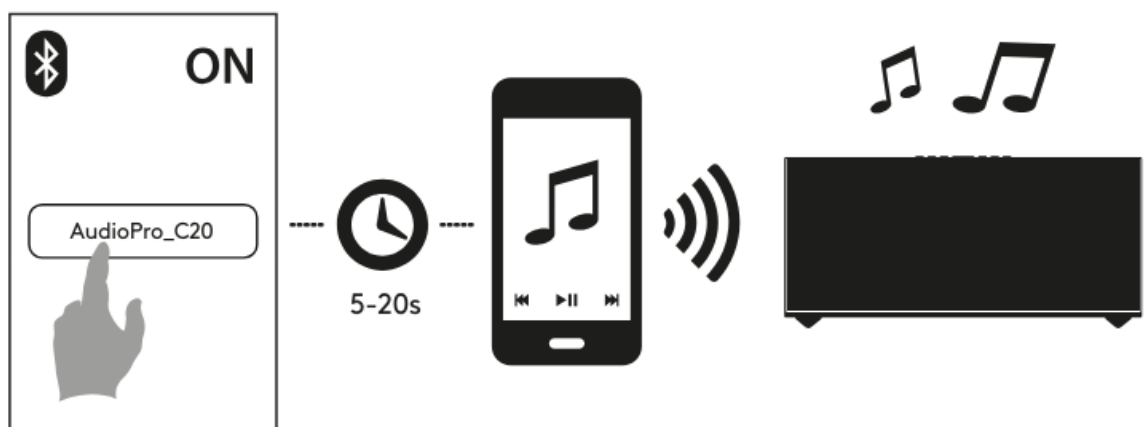
