Avalara's Ava Tax sends real-time sales tax calculations to BigCommerce using geolocation to map multiple rates and rules to each transaction. Once you activate Ava Tax within BigCommerce and set up your company profile, you can configure the setup to fit your unique business requirements for things like:

- Tax calculation settings for various tax types
- Exemption settings if you have exempt customers
- · Product taxability settings for what you sell
