




- 1. Lavalier Microphone (Transmitter UI)
- 2. USB-C Receiver

INSTALLATION



- Plug into device to be power ON (Red light on)
- Plug out from device to be power OFF



- ON-Press and hold the power button for 3 seconds (Red/green lights flash alternately)
- OFF-Press and hold the power button for 3 seconds (light goes out)
- PAIRED-Automatic connection and pairing after startup (Green light is always on)
- NOISE REDUCTION-Press button twice (Green light flashes 1 time, normal sound, Green light flashes 3 times, Noise reduction)

INSTALLATION

CHARGING-TYPE-C (Red light is always on, and red light is off after fully charged)



WITHOUT CONNECTION

Device will be OFF if no connection more than 3 minutes
