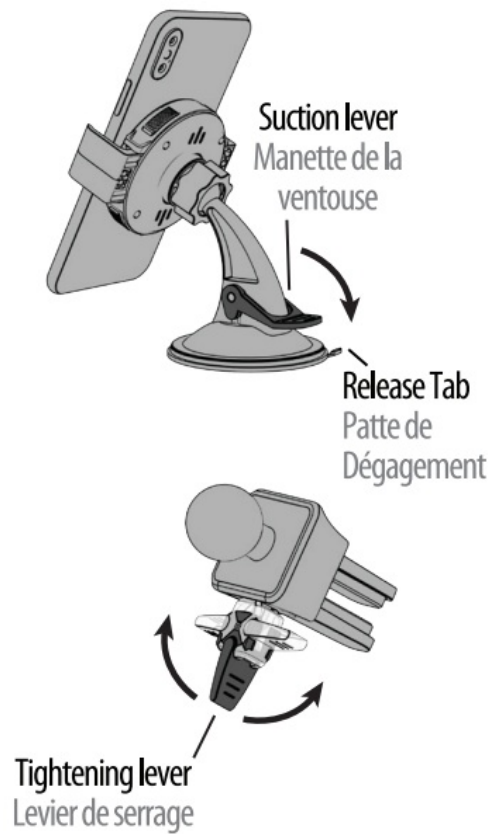
### ASSEMBLY

1. Insert the ball on the mount into the socket on the device holder and
2. Fasten with nut. Ball joint can be adjusted for best viewing angle.
  - Be sure to plug power cord into bottom of device holder or phone will not charge.
  - Join the device holder with either the dash/window mount or vent adapter:



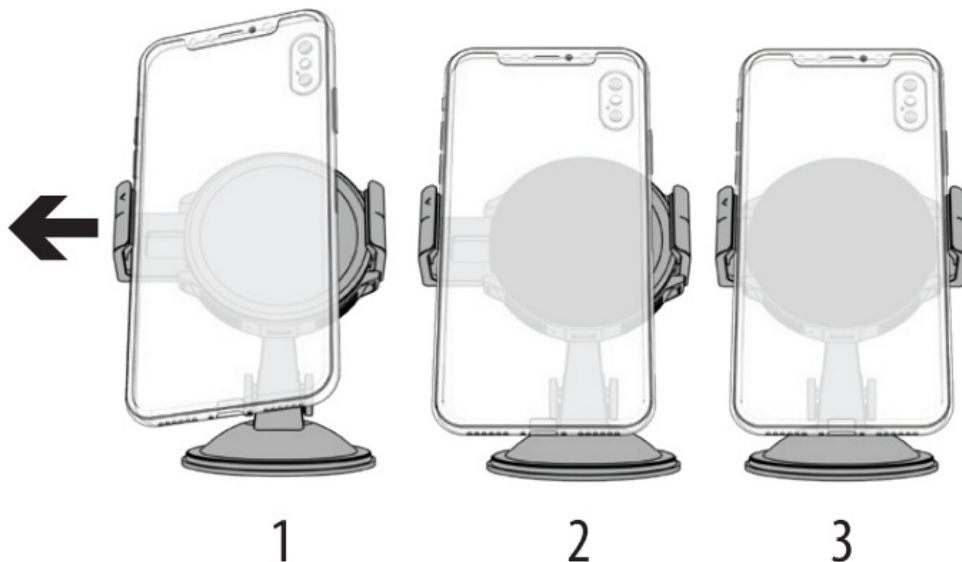
## INSTALLATION

- **Dash Mount:** Clean mounting location with water or alcohol as necessary and let dry. Apply at room temperature. Peel cover off suction cup and press firmly while locking suction lever into down position. To release the mount from your dash, lift up the suction lever and pull up on the release tab. After repeated applications, suction cup may lose its stickiness. Simply wash with warm water and air dry to restore original condition.
- **Vent Adapter:** Flip the tightening lever to its middle position (perpendicular to the vent adapter), then slide jaws of vent mount onto vent slat. Once inserted all the way into the vent, flip the tightening lever to whichever position ("I" or "II") provides the best grip on the vent slat.



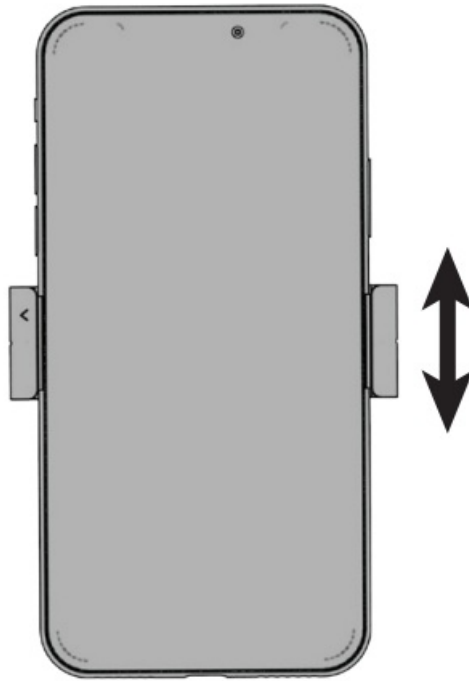
## DEVICE REPLACEMENT

- To insert your smartphone: (1) use the side of your device to expand one of the expanding arms until there is enough room for your phone. Then (2) lower the other edge of the phone into the mount and (3) let go of the phone.
- To release phone, simply pull it forward out of the mount.



## CHARGING ALIGNMENT

Once the phone is inserted, some vertical adjustment might be needed, depending on the device. Your phone will start charging when it is in proper alignment.

### **LIMITED WARRANTY**


