POWER

To power on, slide the power switch on the back of the unit from left to right and the release LED will turn green for three seconds to indicate the trackpad is on To power off, slide the power button to left and release.

PAIR

Once the trackpad is on, slide the power switch to the right (towards the LED) and hold for three seconds LED will flash blue until the trackpad is successfully paired. On your device under Bluetooth settings select Brydge Track.

CHARGE

To charge your Brydge iTrack, insert the supplied USB-C cable into the charging port. The battery is charging when the LED flashes red. The LED will turn off when the battery is fully charged

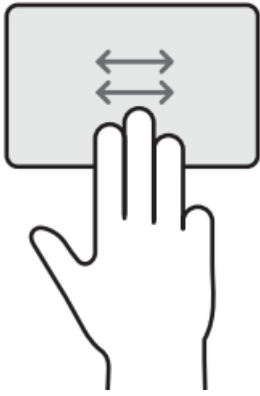
SETTINGS

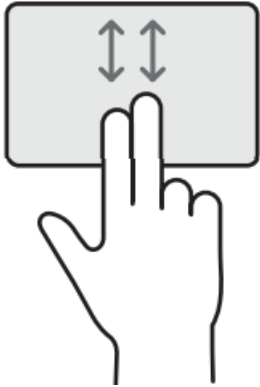
TRACKPAD GESTURES

	<p>Open the App Switcher Swipe up with three fingers, pausing before you lift your fingers</p>
	<p>Go Home Use one finger to swipe the pointer past the bottom of the screen</p>



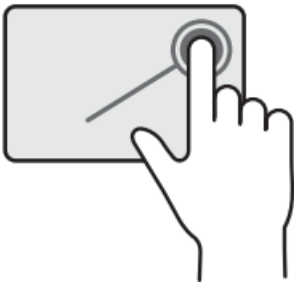
Switch between open apps

Swipe left or right with three fingers



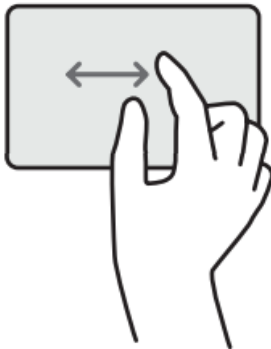
Scroll Up or Down

Swipe two fingers up or down





Open Control Center
