Getting Started

- 3. Switch on the device using the power button on the backside of the recorder.
- 4. The Power LED indicator on the recorder front panel will light up.
- 5. Wait for the boot process to finish.
- 6. Follow the Setup Wizard for initial setup.
- 7. Create a username and password for the first administrator.
- 8. Add your email address for password reset purposes.

FAQ

How many channels does the video recorder support?

The video recorder supports up to 16 channels for input.

What is the maximum resolution supported by the video recorder?

The video recorder supports a maximum resolution of 8MP for AHD/CVI/TVI cameras.

How many USB ports does the video recorder have?

The video recorder has a total of 4 USB ports, with one of them being a Cinch port.





General safety precautions and safety instructions

- Before operating the appliance, please read this manual carefully and retain it for further reference.
- Before cleaning the appliance, it has to be switched off and unplugged from the power outlet. Wipe the appliance with a soft damp cloth.
 - Do not use harsh cleansers or aerosols for cleaning. The type label may not be replaced.
- Do not use attachments unless recommended by the manufacturer as they may affect the functionality of the appliance and result in the risk of fire, electric shock or injury.
