Setup

Connect the BMA 360D, Speakers, PoE Injector, Network Switch, Computer, and Dante Enabled Audio DSP as shown.

1. Install and wire speakers. Using speakers requires the use of a 90 Watt PoE++ injector.
2. Connect a Cat 6 cable (not provided) between the BMA 360D and the PoE Injector.
3. Connect a Cat 6 cable (not provided) between the PoE injector and the network switch.
4. Configure the BMA 360D network and audio properties using Console AI Lite**.
5. Connect the BMA 360D to other Dante enabled devices using Dante Controller**.

Operating Requirements

- PoE Injector: 910-3200-202 PoE Power supply kit, 36 W (No Speakers)
- Speaker Wire: 910-3200-209 PoE Power supply kit, 90 W (Supports Speakers), 24 AWG two conductor
- Network Cable: Solid core, 23 AWG, factory terminated Cat 6

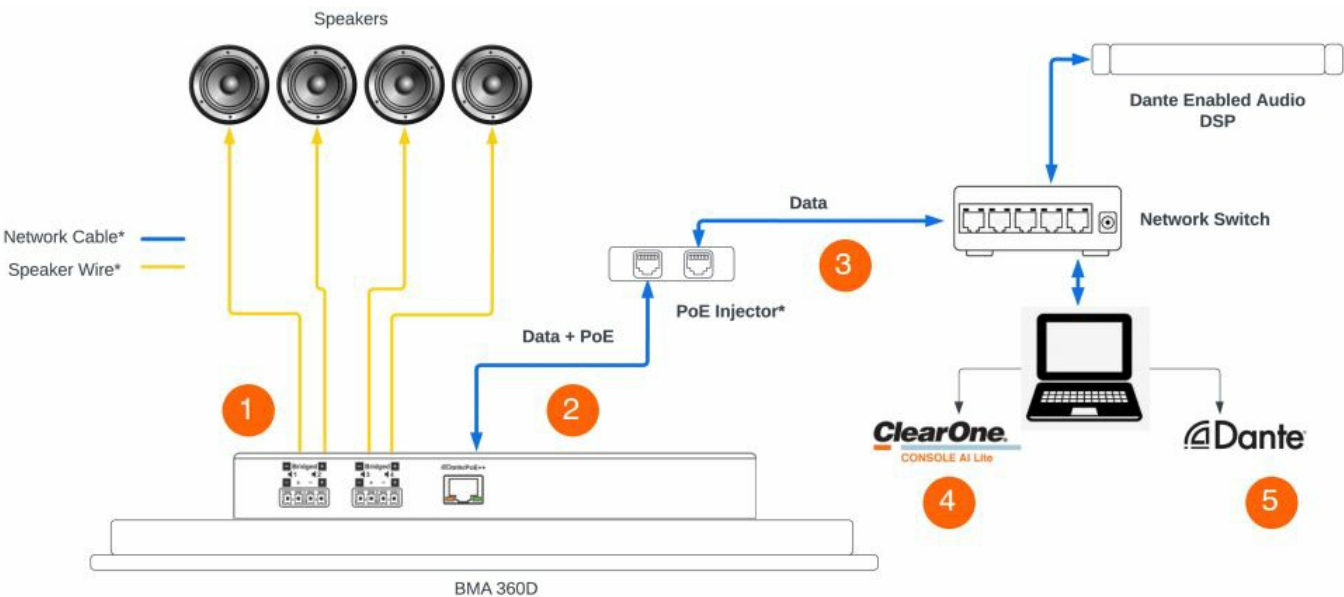

Connections

Refer to the numbered diagram below for these connections.

1. Install and wire speakers. Using speakers requires the use of a 90 Watt PoE++ injector.
2. Connect a Cat 6 cable (not provided) between the BMA 360D and the PoE Injector.
3. Connect a Cat 6 cable (not provided) between the PoE injector and the network switch
4. Configure the BMA 360D network and audio properties using Console AI Lite**.
5. Connect the BMA 360D to other Dante enabled devices using Dante Controller**.
