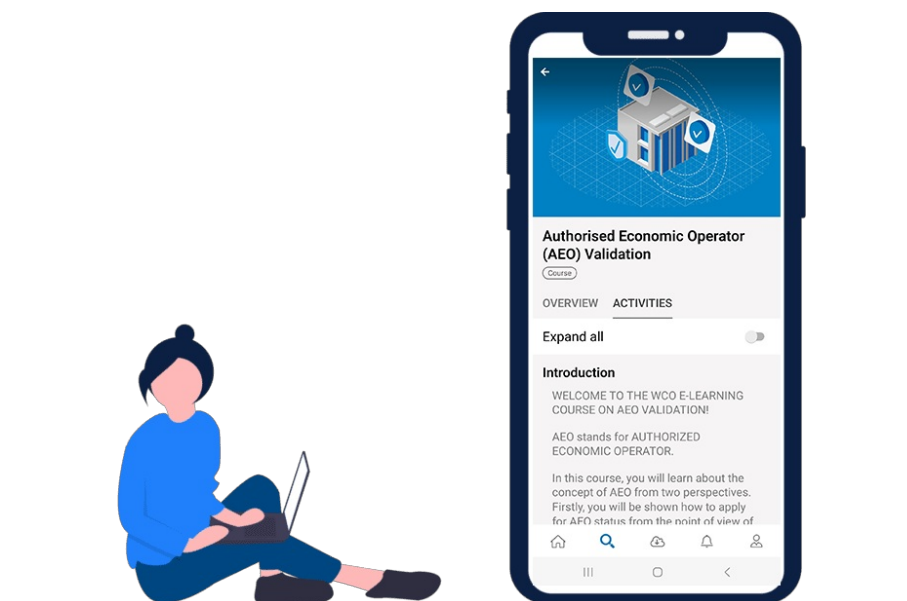

Product Information

The WCO CLiKC! User Guide provides instructions on how to use the CLiKC! platform, which is a training management tool that gives users access to the WCO e-learning program. The platform allows users to connect to selected courses, access learning statistics, communicate with other participants, tutors, and trainers, and more. The manual is divided into chapters that introduce the various functionalities offered by CLiKC!. If users encounter any problems, they can contact the support team at elearning@wcoomd.org for assistance. Before using the platform, users need to create a unique account that grants them full access to the features and contents of CLiKC!. The registration process may take a few days as it requires approval from the user's National Coordinator. The platform is primarily available for Customs officers and government or international officials on a case-by-case basis, and it is free of charge for Customs officers of WCO member administrations. The manual also provides information on the technical prerequisites for using CLiKC!. These include specific requirements for RAM, audio capabilities, internet connection speed, screen resolution, operating system, and web browser compatibility.

Product Usage Instructions

How to Register to CLiKC!

1. Go to the front page of the website.
2. Click on the "Log in" button located at the top right of the screen.
3. On the Log in page, click on the "Create new account" button.
4. Fill in the registration form. All fields marked with a * are mandatory.
5. Read and approve the Terms and Conditions.
6. In the "Choose organization" field, select your country from the list.
7. Click the "Create my new account" button.
8. Check your email inbox for a message containing a confirmation link.
9. Click on the link to confirm your email address.

Note: The registration process requires approval from the user's National Coordinator, and it may take a few days before the confirmation message is sent.

Notes on the platform

The platform you are going to use is called Totara. It is a training management tool giving you access to the WCO e-learning programme: CLiKC!

It will enable you to connect to the selected courses, and to access the various statistics about your learning process.

You will also be able to communicate with all of the e-learning programmed participants who are following the same training paths as you, as well as with your tutors and trainers (when applicable).

What are the technical prerequisites?

It is strongly recommended your computer meets the following technical requirements.

- Hardware specifications

You will need the following minimum hardware configuration:

- **RAM:** 512 MB or higher
- **Audio:** A sound card in order to listen to audio commentary when applicable.
- **Internet connection:** 1 Mbps or higher
- **Screen resolution:** XGA (1024×768) or higher
- You may test the speed of your Internet connection by typing “speedtest” on Google or by going to www.speedtest.net.

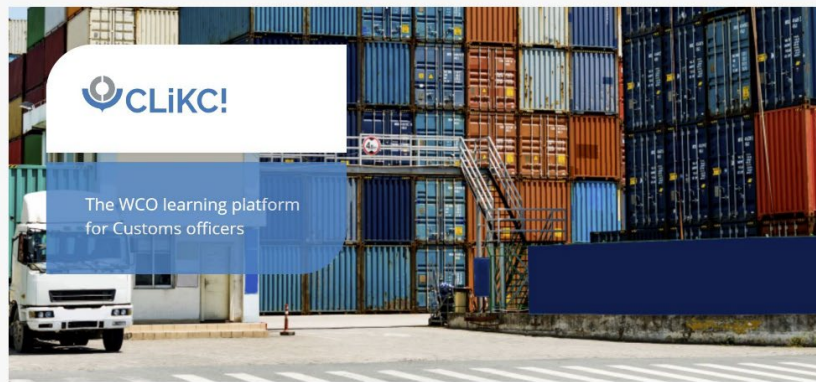
You will need the following software installed on your computer:

- **Operating System:** Windows 7 or above
- **Web browser:**
 - **Chrome:** The latest stable release
 - **Firefox:** The latest stable release
 - **Microsoft** Chromium Edge: The latest stable release
 - **Microsoft** Edge: Versions 16 to 18
 - **Safari:** Version 11.3 or greater
- In order to browse the website problem-free, please enable pop-ups (when prompted by your browser) or disable any pop-up blocking software by following more extensive instructions here:

Create new account


- CLiK! is only available for Customs officers, as well as government or international officials on a case-by-case basis. The platform is free of charge for Customs officers of WCO member administrations.
- Your registration will need to be approved by your National Coordinator, it can take a few days before the confirmation message is sent to you.

Once your registration has been approved, you will receive an email with the subject “CLiK!, the WCO Customs Learning and Knowledge Community: New user account”, sent by elarning@wcoomd.org.

- If you cannot see the email in your inbox folder, check your “junk” or “spam” folders as provided by your email service.

Create new account

Login using the personal codes defined during the registration process. These two codes are strictly personal. You will find the Login block at the left hand side.

- Click on the “Username” field
- Key in your e-mail address
- Click on the “Password” field
- Key in the password defined during registration
- Click “Log in”

This will bring you to your Dashboard.

What if I lose my password?

Due to strict security standards, it is not possible to recover an old password. However, if you follow the “Forgot username password?” link you will be provided with a new password in an email. To receive this email:

- Click on “forgot username or password?”.
- Key in either your username or email.
- Click “search”.
- Check your email inbox.
- Follow the process described in the message .

The main aim of this course is to help trainees use the Harmonized System (HS) Nomenclature in a consistent and effective manner and thus facilitate the classification of internationally traded goods.

Objectives:

- Provide trainees with the necessary tools to understand the classification of various manufactured articles and works of art.
- Provide trainees with effective and suitable resources to understand and master the commodity classification methodology.
- By means of goods classification exercises, equip trainees with the knowledge required to apply the Harmonized System Nomenclature correctly.

It is highly recommended that trainees begin studying the Harmonized System by the [WCO HS Foundation Course](#) which provides an introduction to all the most essential basic concepts of the HS, main categories of commodities, common challenges faced by HS users when classifying products in the HS, as well as the organization of tariff classification work.

This course was developed under the framework of the EU-WCO Programme for Harmonized System in Africa (HS-Africa Programme), funded by the European Union.
