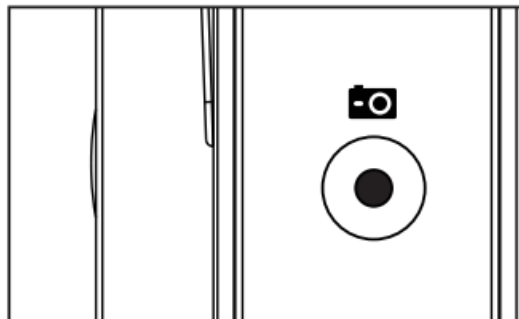

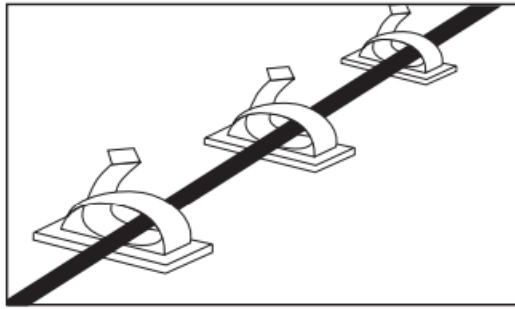

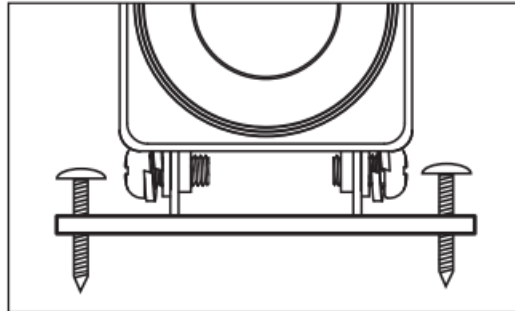
1. Connect Extension Cable to the video Input Port on the Dash Cam.



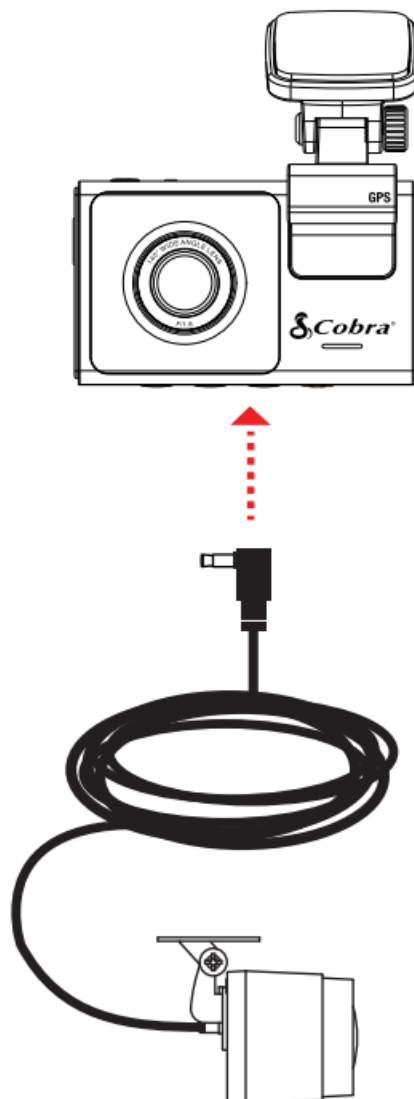
2. Use the included cable routing clips to route the extension cable to the desired mounting location.
