Installation and Operation Instructions

Below Side Mirror Bracket BLAZER-EV 2024+

IMPORTANT! Read all instructions before installing and using. Installer: This manual must be delivered to the end user.



WARNING!

Failure to install or use this product according to manufacturer's recommendations may result in property damage, serious injury, and/ or death to those you are seeking to protect!

Do not install and/or operate this safety product unless you have read and understood the safety information contained in this manual.

- 1. Proper installation combined with operator training in the use, care, and maintenance of emergency warning devices are essential to ensure the safety of emergency personnel and the public.
- 2. Emergency warning devices often require high electrical voltages and/or currents. Exercise caution when working with live electrical connections.
- 3. This product must be properly grounded. Inadequate grounding and/or shorting of electrical connections can cause high current arcing, which can cause personal injury and/or severe vehicle damage, including fire.
- 4. Proper placement and installation is vital to the performance of this warning device. Install this product so that output performance of the system is maximized and the controls are placed within convenient reach of the operator so that they can operate the system without losing eye contact with the roadway.
- 5. Do not install this product or route any wires in the deployment area of an air bag. Equipment mounted or

located in an air bag deployment area may reduce the effectiveness of the air bag or become a projectile that could cause serious personal injury or death. Refer to the vehicle owner's manual for the air bag deployment area. It is the responsibility of the user/operator to determine a suitable mounting location ensuring the safety of all passengers inside the vehicle particularly avoiding areas of potential head impact.

- 6. It is the responsibility of the vehicle operator to ensure daily that all features of this product work correctly. In use, the vehicle operator should ensure the projection of the warning signal is not blocked by vehicle components (i.e., open trunks or compartment doors), people, vehicles or other obstructions.

Installation and Mounting

- 1. Position the mounting bracket as shown in Figure 1.
- 2. Using the bracket as a template, mark the hole location on the mirror.
- 3. Consult the factory service manual to remove the side mirrors from the vehicle.
- 4. Drill two 7/64" diameter holes through the plastic mirror housing at the hole locations previously marked. Drill one 9/32" diameter hole in the mirror housing for cable entry.
- 5. Position the light head up against the mounting bracket and thread two 3.5mm screws and two #6 lock washers through the mounting holes in the back side of the mounting bracket and into the threaded holes of the light as shown in Figure #2. Tighten the screws until the lock washers are fully flat against the bracket. Ensure that the puddle light is in the proper orientation.
- 6. Route wiring through side mirror into the vehicle. Add wire length if necessary.
- 7. Thread two #8 screws through the holes in the mounting bracket and into the holes drilled in the mirror housings. Tighten the screws until they bottom out and fasten the bracket securely to the mirror housings.

Note: Tighten the screws just enough to pull the bracket up against the plastic mirror housing! Do not over tighten the screws as they could strip out the plastic!

- 8. Reattach mirror using factory service manual.
- 9. Repeat process for opposite side mirror.


