OPERATING INSTRUCTIONS

TRANSMITTER MODE (TX)

The transmitter mode (TX) lets you transmit audio from a non-Bluetooth device (e.g., an airplane screen or gym equipment) to a Bluetooth device (e.g. headphones).

- 1. Turn off Bluetooth on your cell phone.
- 2. Connect the adapter to the non-Bluetooth device (e.g. airplane screen or gym equipment).
- 3. Make sure the adapter's switch is on TX.
- 4. Press and hold the button for 3 seconds to turn on the adapter (the Bluetooth indicator will flash red/blue.
- 5. Turn on the Bluetooth device (e.g. headphones). The device will automatically pair with the adapter within a few seconds. Once paired, the Bluetooth indicator will flash blue for 3 seconds.

RECEIVER MODE (RX)

The receiver mode (RX) lets you receive audio from a Bluetooth device (e.g. phone or tablet) and transmit it to a non-Bluetooth device with an AUX-in port (e.g. car or home speaker).


- 1. Make sure the adapter's switch is on RX.
- 2. Press and hold the button for 3 seconds to turn on the adapter (the Bluetooth Indicator will flash red/blue).
- 3. Turn on your Bluetooth device (e.g. phone) and make sure Bluetooth is turned on. Please search and pair the device to ConairTS282. Once paired, the Bluetooth indicator will flash blue for 3 seconds. After pairing successfully, plug the adapter's AUX Plug into the AUX-In port of the non-Bluetooth device.
 NOTE: If pairing isn't achieved within 15 minutes, the adapter will turn off.

OPERATION GUIDE

To turn off the Bluetooth adapter	Press and hold the b
To turn on and pair the Bluetooth adapter	Press and hold the ${\color{blue} {0}}$ button 3 seconds; the Bluetooth indicator will flash red/blue.
To pick up a call	Press the U button once
To transfer call/voice back to cell phone	Press the U button twice
To hang up a call	Press the ${\color{red} {\bf 0}}$ button (music will resume if it was playing)
To play music	After pairing successfully, press the b button to play and press it again to stop.
To call most recent number	After pairing successfully, press the b button twice (music will stop if it was playing)

CHARGING INSTRUCTIONS

Fully charge the adapter prior to using itfor the first time, every 3 months, and when it hasn't been used for a long period of time. The red charging indicator will flash when the adapter needs to be charged.

- 1. Turn the adapter off, and connect it to a certified 5V USB power supply using a USB-C charging cable (not included). The red charging indicator will light.
- 2. Once fully charged, the charging indicator will turn off.

Precaution: Do not use a USB power supply higher than 5V to charge the adapter.

INDICATOR LIGHTS

- Pairing Bluetooth Indicator flashes red/blue
- Paired successfully Bluetooth Indicator flashes blue
- Low power Red Charging Indicator flashes

BATTERY SAFETY INFORMATION FOR RECHARGEABLE BATTERIES

- 1. This device contains a lithium battery pack.
- 2. Batteries are not to be removed by the consumer unless instructed by the manufacturer.
- 3. Since batteries are sensitive to high temperatures, when storing, keep the device in a cool dry place.
- 4. Never put batteries into a fire.
- 5. Switch off device after use.

- Q: What should I do if the adapter doesn't pair within 15 minutes?
 - A: If pairing isn't achieved within 15 minutes, the adapter will turn off. In this case, you can restart the
 pairing process by turning on the adapter and your Bluetooth device again and initiating the pairing

sequence.
