To Recycle Trackers

Follow these simple steps:

- 1. **Email us** for boxes and pre-paid labels.
- Fill box with GO Tracker devices and use Tracker
 Return Form. Note: Lithiumion battery warning label must be used. Email for label if using your own box.
- 3. Attach provided FedEx label to outside of box and ship via FedEx.
- Pre-paid FedEx label

Important Requirements

Do not ship more than 80 devices per box – weight must not exceed 30lbs. Do not ship damaged GO Trackers. Please dispose of the damaged tracker in accordance with applicable laws and regulations.
