Product Diagram



1. Skip backward/Volume Long Press to the previous track, Short press to decrease the volume
2. MFB Button (Play/Pause/paly back/ Phone-Answer/Deny incoming call /Power ON/OFF
3. Skip forward/Volume Long Press to the next track, Short press to increase the volume

Pairing Instruction

1. Press the Power switch button for about 3 seconds you will hear a voice power on, the led indicator light will quickly flash.
2. Connect it with your Bluetooth device by searching "Curtis CSP062". If a password is needed, please enter "000". When Bluetooth is paired successfully, you will hear a sound.
3. The unit will be auto power off in 5 minutes during the Bluetooth is disconnected or not connected.

Charging Instruction

Plug the charging cable to the micro-USB port at the back of the device, make sure that your speaker is fully charged for 12 hours before initial use. While charging, the red LED light is constantly on. Normal charging 3 hours, when charging is completed, the blue LED light is on.
