TERMS AND CONDITIONS

- 1. The offer is valid until 30 September 2023.
- 2. The free installation offer is valid for new and existing customers of the Internet service provided they commit to maintain the Internet service for a continuous period of 12 months from the connection date.
- 3. In case of termination or transfer to another customer of the Internet service before the end of the above mentioned commitment period (12 months), the customers shall be obliged to pay to Cyta the relevant amount of the installation fee* which shall apply on the date of termination or transfer of the service.
- 4. The 12month commitment shall not be renewed by Cyta. After the end of the 12month period, the customers shall continue to be Internet customers without any commitment.
- 5. Cyta reserves the right to amend the present terms.

PROVISION TERMS AND CONDITIONS
