Product Overview

1.1. General Description

The VCB601-ZB01 is a Zigbee data collector module that can collect data from other devices With a TTL serial port and then send out data through Zigbee. This device is a built-in Silicon LAB EFR32MG1B232F256GM48 which is a highly integrated single-chip low power Wireless on Chip controller. The EFR32MG1B232F256GM48 combines an ARM-Cortex M4 with DSP instruction, MCU, and 2.4G RF in a single chip. It provides a UART interface. It also provides a bunch of configurable GPIOs which are configured as digital peripherals for different applications and controls.

Statement

Federal Communication Commission Interference Statement

- 1) The antenna must be installed such that 20 cm is maintained between the antenna and users, and
- 2) The transmitter module may not be co-located with any other transmitter or antenna.

As long as the 2 conditions above are met, further transmitter tests will not be required. However, the OEM integrator is still responsible for testing their end-product for any additional compliance requirements required with this module installed

IMPORTANT NOTE: In the event that these conditions can not be met (for example certain laptop configurations or co-location with another transmitter), then the FCC authorization is no longer considered valid and the FCC ID can not be used on the final product. In these circumstances, the OEM integrator will be responsible for reevaluating the end product (including the transmitter) and obtaining a separate FCC authorization.

End Product Labeling

This transmitter module is authorized only for use in devices where the antenna may be installed such that 20 cm may be maintained between the antenna and users. The final end product must be labeled in a visible area with the following: "Contains FCC ID: 2AMVP-VCB601V2". The grantee's FCC ID can be used only when all FCC compliance requirements are met.

Manual Information To the End-User

The OEM integrator has to be aware not to provide information to the end-user regarding how to install or remove this RF module in the user's manual of the end product which integrates this module. The end-user manual shall include all required regulatory information/warning.
