




Charging

App downloads and pairing

App downloads

Scan the QR code on the right, and download the "GloryFit" APP from "APP Store" or "Google play".

Pairing

Turn on GloryFit app -> Activate Bluetooth connection on your phone -> Search on the app for the device to pair with (or scan the QR code on the device) -> Finish binding on the app (or on the device).

Screen operation

Swipe up: Enter the push information page

Swipe down: Enter the shortcut key function setting page

Swipe to the left: Enter the weather interface to view recent weather information.

Swipe to the right: Enter the page of steps, mileage, and consumption status of the day.

Features

Metal thin and light body (multiple colors are available) non-sense wear, 24H*7 real-time heart rate, accurate step counting, APP massive dials optional, custom dials can be edited, support Android/105 mobile message push.

Attention information

- 1. When using the watch for the first time, please fully charge the watch.
- 2. Please do not disassemble it by yourself. If your watch fails, please contact our designated after-sales service center.
- 3. Charging must be carried out under the condition of good ventilation and heat dissipation, away from flammable and explosive materials.
- 4. Avoid using it in an environment where the temperature is too high and then too low, and avoid exposing it to strong sunlight or an environment with high humidity. 5. When the use of the watch may cause interference or danger, please do not turn it on.
- 5. Keep the equipment dry. For stains that are difficult to remove, it is recommended to use a non-soa cleaner and scrub with alcohol.
- 6. Waterproof performance: This product is not suitable for diving, swimming, swimming in the sea or the wild, suitable for shower (old water) swimming and shallow water swimming.
- 7. If the content described in this manual does not match your watch, please refer to the actual product.

The device has been evaluated to meet general RF exposure requirements. The device can be used in portable exposure conditions without restriction.



The device meets the EU ROHS criterion.

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions:

- If you have eczema, allergies, or asthma, you may be more likely to experience skin irritation or allergy from a wearable device.
