
- Read the installation guide thoroughly before you set up the switch.






• UK-type Power Cord




• EU-type Power Cord



• USA/Taiwan-type Power Cord



Panel Explanation



LED	Status	Explanation
Monitor	On (Red)	An alert for system failure due to overheating or wrong voltage.
	Off	The device is in normal condition and running normally.
Alert	Blinking (Green)	The power is over (>) 80% watts PoE power budget.
	Off	The power is under (<) 80% watts PoE power budget.
	On (Green)	The switch finishes system booting and the system is ready.
SYS	Blinking (Green)	The switch is powered on and starts system booting.

	Off	The power is off or the system is not ready / malfunctioning.
PWR	On (Green)	The device is powered on and running normally.
	Off	The device is not ready or is failed.
Port 1 ~ 24 (PoE)	On (Green)	The port is supplied with PoE power.
	Off	No PoE power is supplied on the port.
	On (Green)	The device is connected with 1000Mbps.
Port 1 ~ 24 (GbE RJ45)	On (Amber)	The device is connected with 10/100Mbps.
	Blinking	The system is sending or receiving data through the port.
	Off	The port is disconnected or the link is failed.
Port 25 ~ 28 (SFP+)	On (Blue)	The device is connected with 10Gbps.
	On (Green)	The device is connected with 1000Mbps.
	Blinking	The system is sending or receiving data through the port.
	Off	The port is disconnected or the link is failed.

Port 1 ~ 24 (GbE RJ45)	Port 1 to Port 24 can be used for Ethernet connection and PoE con
Port 1 ~ 24 (PoE)	nection, depending on the device connected.
Port 25 ~ 28 (SFP+)	Port 25 to Port 28 are used for fiber connection.
Console	Used to perform telnet command control.
	Power inlet for AC input (100~240V/AC, 50/60Hz).

Hardware Installation

This section will guide you to install the switch through hardware connection and configure the switch's settings through web browser.


Before starting to configure the switch, you have to connect your devices correctly.



Note Power the device to this switch and get 54V power source through Cat. 5e Cable.

Network Connection


- Use a Cat. 5e twisted-pair cable to connect a PoE device to the port (1~24) of this switch.
- The switch will supply power to PoE Device over the twisted-pair cable.
- Please note that Power Device must comply with IEEE 802.3af/at.
- Other PCs, servers and network devices can be connected to the switch using a standard 'straight through' twisted pair cable.




Rack-Mounted Installation

The switch can be installed easily by using rack mount kit.

1. Fasten the rack mount kit on both sides of the VigorSwitch using specific screws.



2. Then, install the VigorSwitch (with rack mount kit) on the 19-inch chassis by using other four screws.




Software Configuration

Before using the switch, perform the following steps:

1. Set up a physical path between the configured the switch and a PC by a qualified UTP Cat. 5e cable with RJ-45 connector.

If a PC directly connects to the switch, you have to setup the same subnet mask for PC and the switch. Default values of the managed switch are listed as follows:

Subnet Mask	255.255.255.0
DHCP Client	Enabled (On)
Username	admin
Password	admin

2. After configuring correct IP address on your PC, open your web browser and access switch's IP address.
