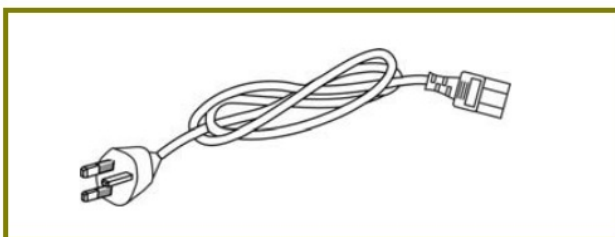

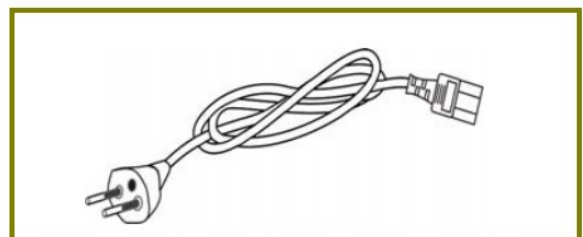


Rack Mount Kit (brackets)

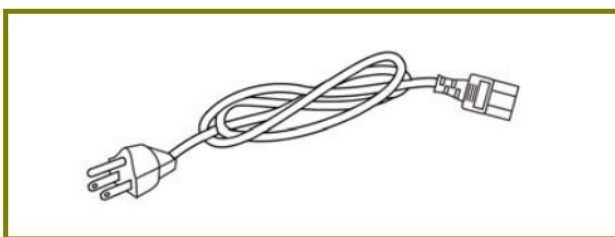
The type of the power cord depends on the country that the switch will be installed.



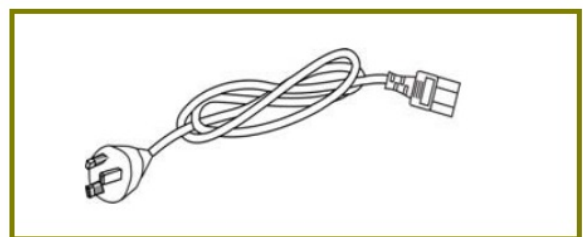
UK-type Power Cord



EU-type Power Cord



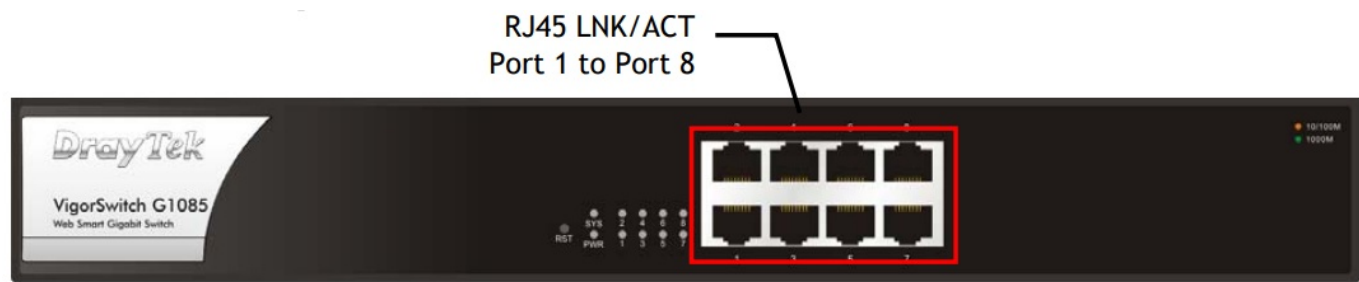
USA/Taiwan-type Power Cord

Panel Explanation



LED	Status	Explanation
SYS	On (Green)	The switch finishes system booting and the system is ready.
	Blinking (Green)	The switch is powered on and starts system booting.
	Off	The power is off or the system is not ready /malfunctioning.
PWR	On (Green)	The device is powered on and running normally.
	Off	The device is not ready or is failed.

Interface	Description
RST	Factory reset button. I Press it to reboot the system. (<5 seconds) The SYS LEDs will blink too. I Press it to reset the system with factory default settings. (5~20 seconds) The SYS LED will be off if RST button is pressed between 5 seconds and 10 s econds.
RJ 45 LNK/ACT Port 1 ~ 8	Port 1 to Port 8 are used for Ethernet connection.
	Power inlet for AC input (100~240V/AC, 50/60Hz).

Hardware Installation

Before starting to configure the switch, you have to connect your devices correctly.

3.1 Network Connection

Use the Ethernet cable(s) to connect None-PoE devices to the Vigor switch. All device ports are in the same local area network.

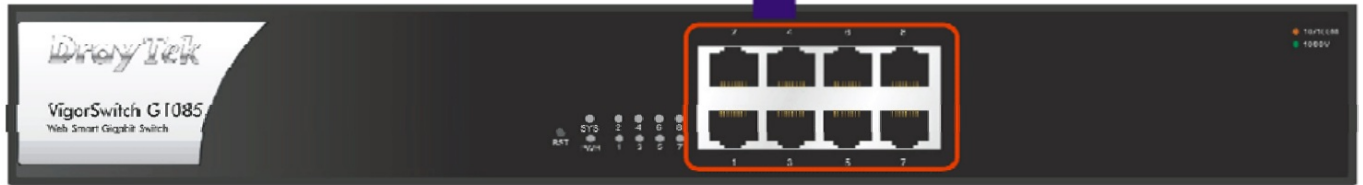

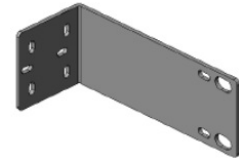

3.2 Rack-Mounted Installation

The switch can be installed easily by using rack mount kit. 1. Fasten the rack mount kit on both sides of the Vigor Switch using specific screws. 2. Then, install the Vigor Switch (with rack mount kit) on the 19-inch chassis by using other four screws.



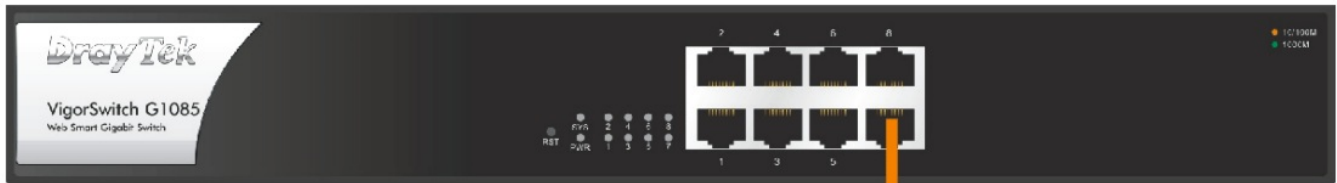

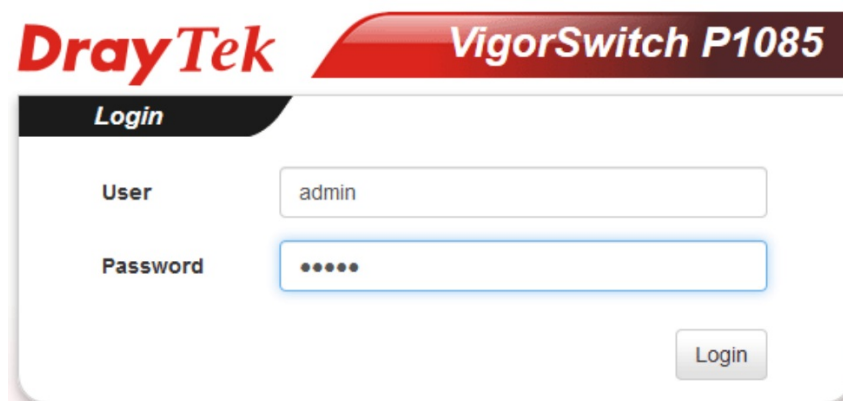
Before using the switch, perform the following steps:

1. Set up a physical path between the configured the switch and a PC by a qualified UTP Cat. 5e cable with RJ-45 connector.

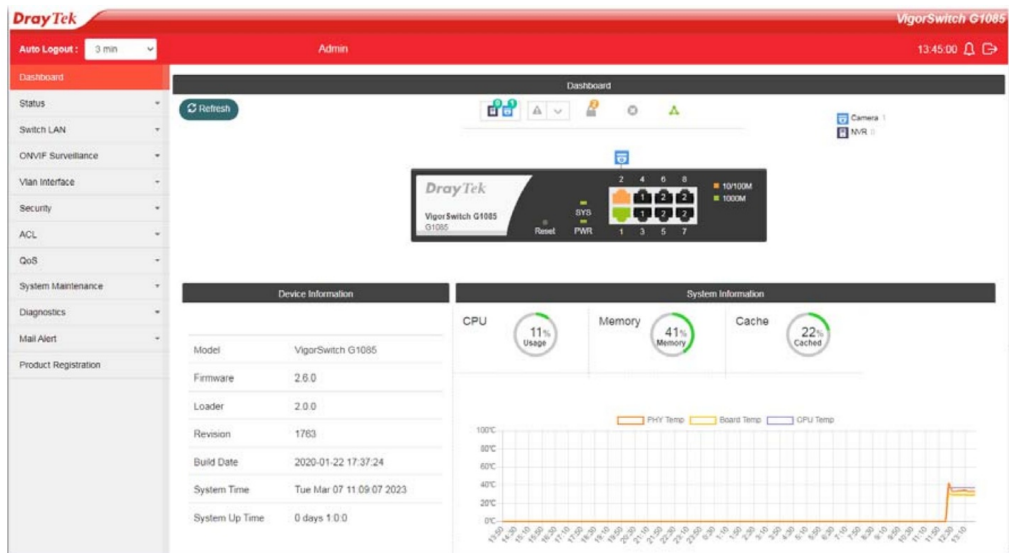
If a PC directly connects to the switch, you have to setup the same subnet mask for PC and the switch. Default values of the managed switch are listed as follows

IP Address	192.168.1.224
Subnet Mask	255.255.255.0
DHCP Client	Enabled (On)
Username	Username admin
Password	Password admin

2. After configuring correct IP address on your PC, open your web browser and access switch's IP address.


