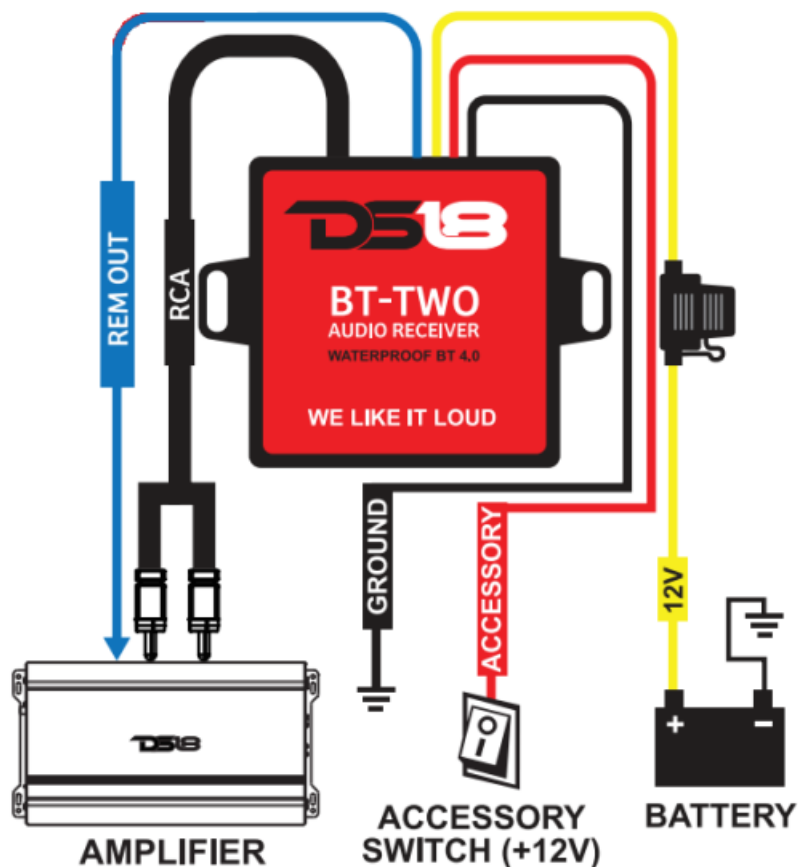

## FCC Statement
