Product Information

- Exterior foliage (i.e. trees, shrubs, bushes, etc.) should be kept trimmed, especially around doors, windows, and sidewalks.
- Key cards that permit access to buildings, guest rooms, and other amenities should be immediately deactivated if they are reported lost and following customer stays.
