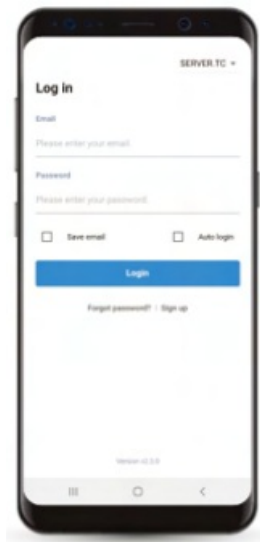

- Please select the device you want to install.

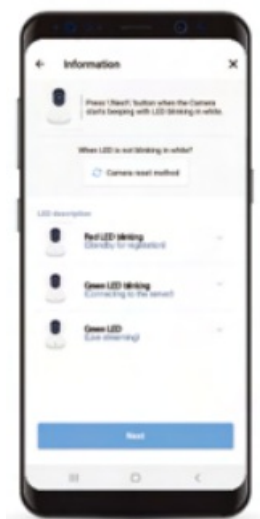


Camera registration

Check the status of camera



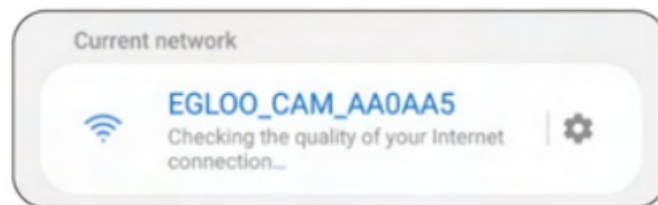
- When you hear installation message from camera and the Red LED starts to flicker, please tap the “Next” button

Connect smart phone to Camera



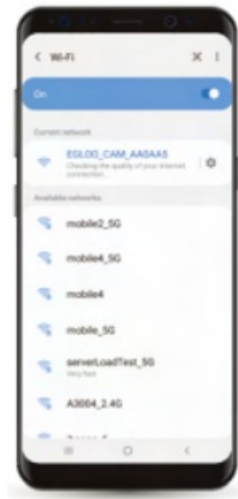
Android Phone

Enter Wi-Fi password

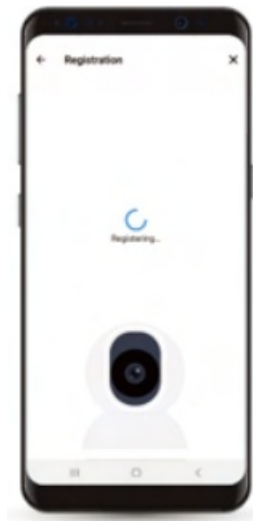

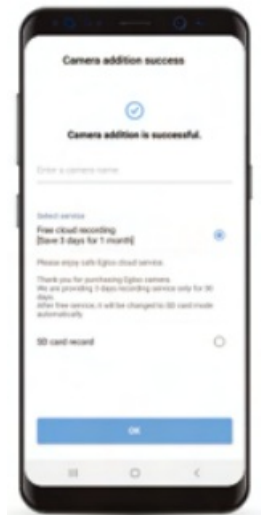
Connecting to server
