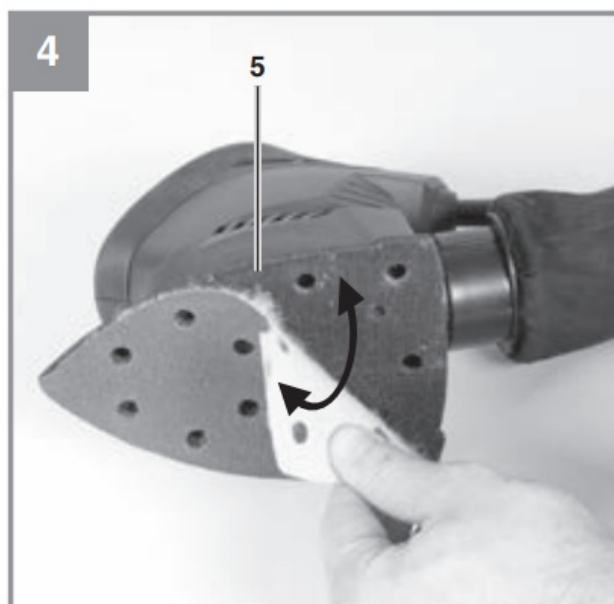
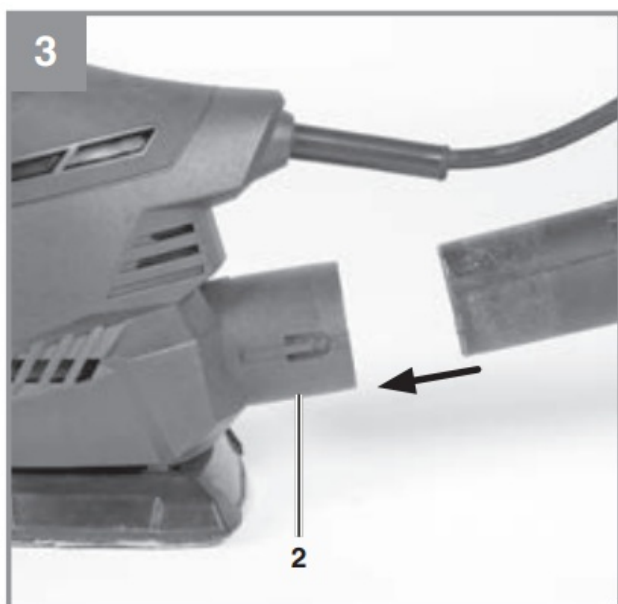
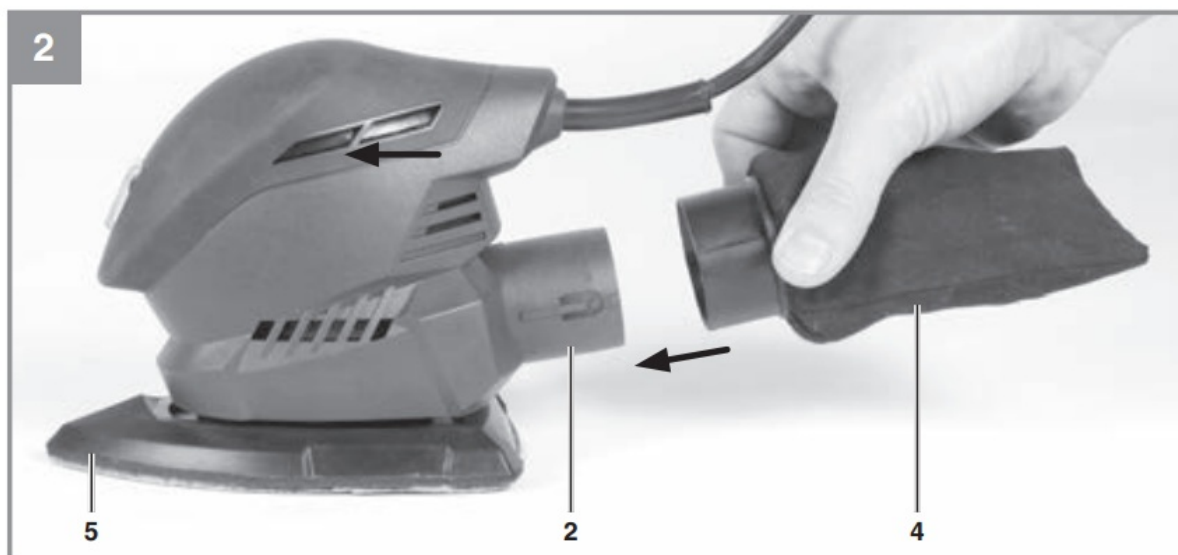

	Caution – Read the operating instructions to reduce the risk of injury.
	Wear ear-muffs. The impact of noise can cause damage to hearing.
	Wear a breathing mask. Dust which is injurious to health can be generated when working on wood and other materials. Never use the device to work on any materials containing asbestos!

Layout and items supplied

### **2.1 Layout (Fig. 1/2)**

1. On/Off switch
2. Vacuum extractor connection
3. Handle
4. Dust bag
5. Oscillating plate

### **2.2 Items supplied**

Please check that the article is complete as specified in the scope of delivery. If parts are missing, please contact our service center or the nearest branch of the DIY store where you made your purchase at the latest within 5 work days after purchasing the article and upon presentation of a valid bill of purchase. Also, refer to the warranty table in the warranty provisions at the end of the operating instructions.

- Open the packaging and take out the equipment with care.
- Remove the packaging material and any packaging and/or transportation braces (if available).
- Check to see if all items are supplied.
- Inspect the equipment and accessories for transport damage.
- If possible, please keep the packaging until the end of the guarantee period.

### **Important!**

The equipment and packaging material are not toys. Do not let children play with plastic bags, foils or small parts. There is a danger of swallowing or suffocating!

## **Proper use**

The machine is designed for the grinding/sanding of wood, metal, plastic and similar materials using the appropriate grinding/sanding paper.

The equipment is not suitable for wet grinding/ sanding. The equipment is to be used only for its prescribed purpose. Any other use is deemed to be a case of misuse. The user / operator and not the manufacturer will be liable for any damage or injuries of any kind caused as a result of this.

Please note that our equipment has not been designed for use in commercial, trade or industrial applications. Our warranty will be voided if the machine is used in commercial, trade or industrial businesses or for equivalent

purposes.

## Sound and vibration

Sound and vibration values were measured in accordance with EN 62841.

LpA sound pressure level ..... 79 dB(A)  
KpA uncertainty ..... 3 dB  
LWA sound power level ..... 90 dB(A)  
KWA uncertainty ..... 3 dB

## Wear ear-muffs.

The impact of noise can cause damage to hearing.

Total vibration values (vector sum of three directions) determined in accordance with EN 62841.

Vibration emission value  $a_h = 7.5 \text{ m/s}^2$

K uncertainty =  $1.5 \text{ m/s}^2$

The stated vibration emission levels and stated noise emission values were measured in accordance with a set of standardized criteria and can be used to compare one power tool with another.

The stated vibration emission levels and stated noise emission values can also be used to make an initial assessment of exposure.

## Warning:

The vibration and noise emission levels may vary from the level specified during actual use, depending on the way in which the power tool is used, especially the type of workpiece it is used for..

## Keep the noise emissions and vibrations to a minimum.

- Only use appliances which are in perfect working order.
- Service and clean the appliance regularly.
- Adapt your working style to suit the appliance.
- Do not overload the appliance.
- Have the appliance serviced whenever necessary.
- Switch the appliance off when it is not in use.
- Wear protective gloves.

## Limit the operating time!

All stages of the operating cycle must be considered (for example, times in which the electric tools are switched off and times in which the tool is switched on but operates without load).

## Residual risks

Even if you use this electric power tool in accordance with instructions, certain residual risks cannot be ruled out. The following hazards may arise in connection with the equipment's construction and layout:

1. Lung damage if no suitable protective dust mask is used.
2. Damage to hearing if no suitable ear protection is used.
3. Health damage caused by hand-arm vibrations if the equipment is used over a prolonged period or is not properly guided and maintained.

## **Before starting the equipment**

Before you connect the equipment to the mains supply make sure that the data on the rating plate are identical to the mains data.

Always pull the power plug before making adjustments to the equipment.

### **5.1 Fitting the dust bag (Fig. 2-3/Item 4)**

- Slip the dust bag (4) onto the dust extraction connector (2).
- The dust is extracted directly into the dust bag through the abrasive paper and the oscillating plate (5).
- To empty the dust bag, open it and carefully tap out the contents.
- You can also connect the equipment by the dust extraction connector (2) directly to a suitable vacuum cleaner (Fig. 3).

### **Important!**

For health reasons it is imperative that you use the dust bag or a dust extraction system.

### **5.2 Fastening the abrasive paper with the hook-and-loop fastening system (Fig. 4)**

- Only use sanding/grinding paper of the appropriate size and suitable perforations.
- Place the sanding/grinding paper on the oscillating plate (5) as shown in Fig. 4. Make sure that the perforations in the sanding/grinding paper line up with the oscillating plate.

## **Operation**

### **6.1 Switching the equipment ON/OFF (Fig. 1/Item 1)**

To switch on the equipment, slide the switch (1) from 0 to 1.

### **6.2 Working with the Multiple Grinder/Sander**

- Place the whole surface area of the sanding disk on the material.
- Switch on the machine and move it with gentle pressure over the workpiece completely circular movements or moving it to and for and up and down.
- Use a coarse paper for coarse sanding and a finer paper for finish sanding. You can find the best paper for the job by means of testing.

### **Important.**

The dust generated when working with the machine may be harmful.

- Always wear goggles and a dust mask when carrying out sanding/grinding work.
- Everybody who uses the machine or enters the workplace must wear a dust mask.
- Do not eat, drink or smoke at the workplace.
- Do not use the machine on paints which contain lead.

## **Replacing the power cable**

If the power cable for this equipment is damaged, it must be replaced by the manufacturer or its after-sales service or similarly trained personnel to avoid danger.

## **Cleaning, maintenance and ordering of spare parts**

Always pull out the mains power plug before starting any cleaning work.

### **8.1 Cleaning**

- Keep all safety devices, air vents and the motor housing free of dirt and dust as far as possible. Wipe the equipment with a clean cloth or blow it with compressed air at low pressure.
- We recommend that you clean the device immediately each time you have finished using it.
- Clean the equipment regularly with a moist cloth and some soft soap. Do not use cleaning agents or solvents; these could attack the plastic parts of the equipment. Ensure that no water can seep into the device. The ingress of water into an electric tool increases the risk of an electric shock.

### **8.2 Carbon brushes**

In case of excessive sparking, have the carbon brushes checked only by a qualified electrician. Important! The carbon brushes should not be replaced by anyone but a qualified electrician.

### **8.3 Maintenance**

There are no parts inside the equipment which require additional maintenance.

### **8.4 Ordering replacement parts:**

Please quote the following data when ordering replacement parts:

- Type of machine
- Article number of the machine
- Identification number of the machine
- Replacement part number of the part required

## **Disposal and recycling**

The equipment is supplied in packaging to prevent it from being damaged in transit. The raw materials in this packaging can be reused or recycled. The equipment and its accessories are made of various types of material, such as metal and plastic. Never place defective equipment in your household refuse. The equipment should be taken to a suitable collection center for proper disposal. If you do not know the whereabouts of such a collection point, you should ask in your local council offices.

## **Storage**

Store the equipment and accessories out of children's reach in a dark and dry place at above freezing temperature. The ideal storage temperature is between 5 and 30°C. Store the electric tool in its original packaging.

1. These guarantee terms apply to consumers only, i.e. natural persons intending to use this product neither for their commercial activities nor for any other self-employed activities. These warranty terms regulate additional warranty services, which the manufacturer mentioned below promises to buyers of its new products in addition



to their statutory rights of guarantee. Your statutory guarantee claims are not affected by this guarantee. Our guarantee is free of charge to you.

2. The warranty services cover only defects due to material or manufacturing faults on a product which you have bought from the manufacturer mentioned below and are limited to either the rectification of said defects on the product or the replacement of the product, whichever we prefer. Please note that our devices are not designed for use in commercial, trade or professional applications. A guarantee contract will not be created if the device has been used by commercial, trade or industrial business or has been exposed to similar stresses during the guarantee period.
3.
