Product Usage Instructions

Step 1: Create a Delivery PIN

- 1. Open the eufy Security app.
- 2. Go to Device Page > Delivery PIN.
- 3. Create a Delivery PIN for SmartDrop.

Step 2: Include Delivery PIN for Your Delivery Address

Couriers should deliver packages to the address provided, including the Delivery PIN.

Step 4: Take Packages Out of SmartDrop after Delivery

You have two options to retrieve your packages:

1. Option 1: Use the Master PIN.

2. Option 2: Use the Delivery box code (87654321).

Powering Options

Option 1: Battery-powered

1. Remove the battery from SmartDrop.

2. Charge the battery using the provided cable until the LEDs turn solid blue.

Option 2: Wired

Connect SmartDrop to a power source using appropriate cables.



Vandal-Proof Design: SmartDrop is secured by bolts on both top and bottom panels, and cannot be disassembled when it is locked or via the bolts on the sides.






OPTION 1. Battery-powered
