

NHT06 Wi-Fi Countdown Timer Switch



Model - NHT06W

LED indicator
ON/OFF
Override Button
Press and hold for 5 seconds,
normally open (one time)

Hold the button (10 Min) 5s
The LED indicator flashing for 3s
then setting LED indicator turn
on/off.

Hold the button (4 Hour button)
until all indicators light up, keep press
the button to adjust a higher brightness then release the button.




