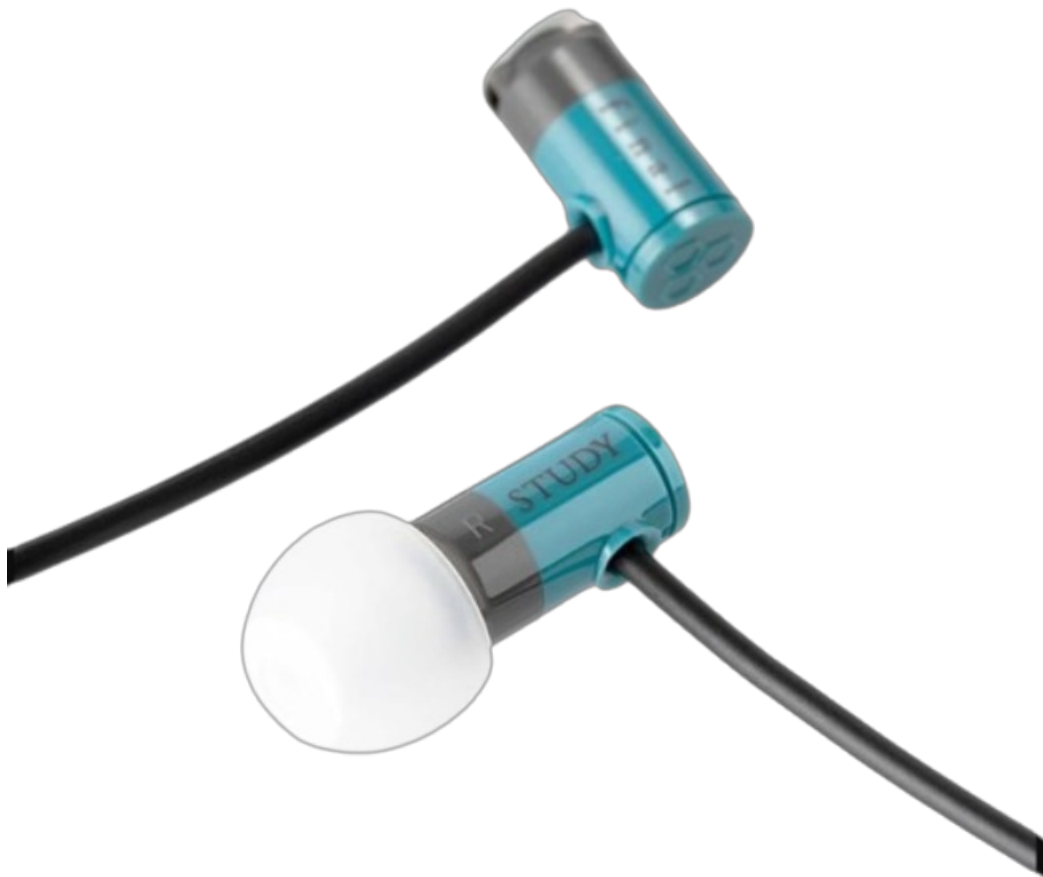

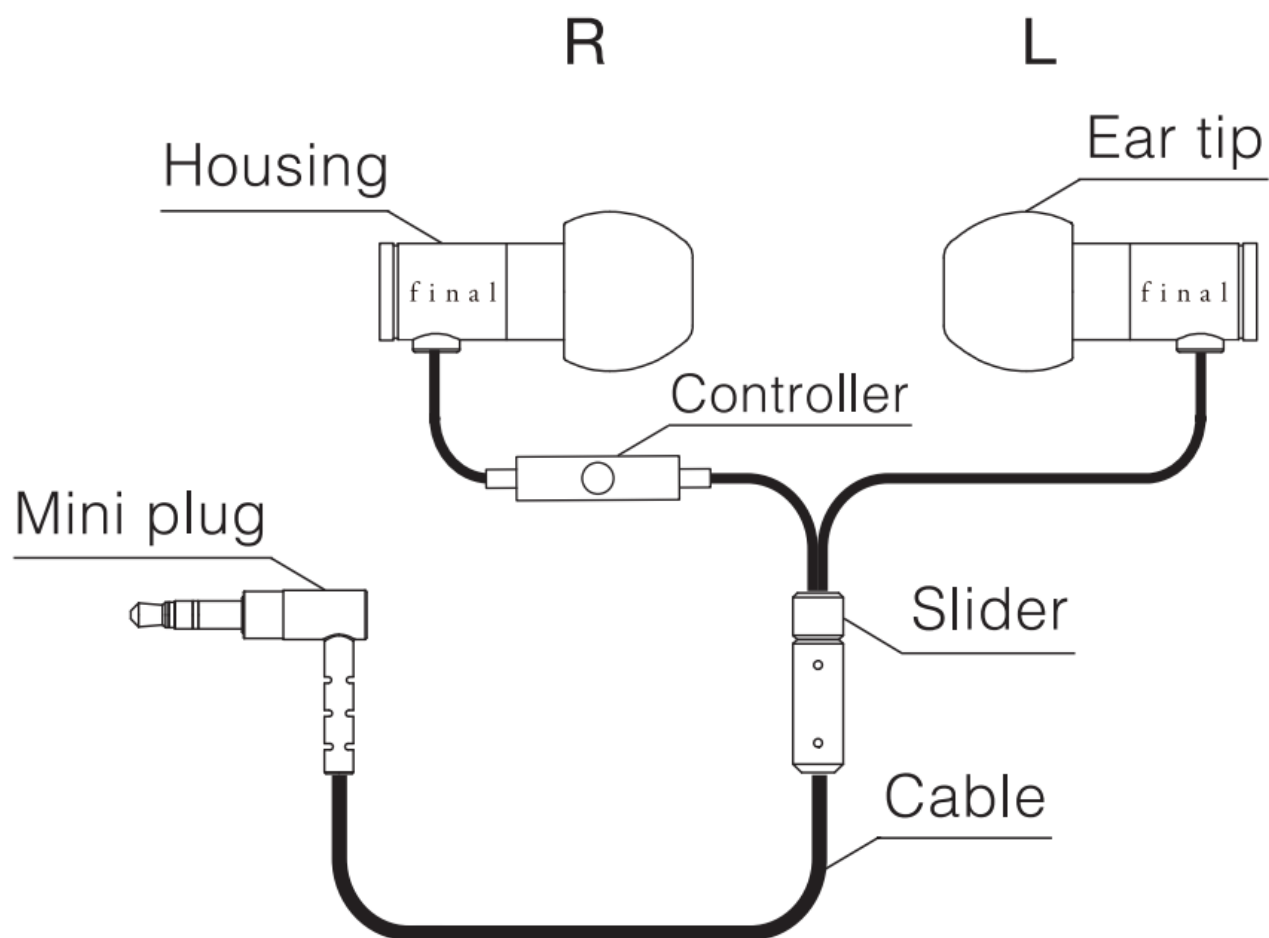

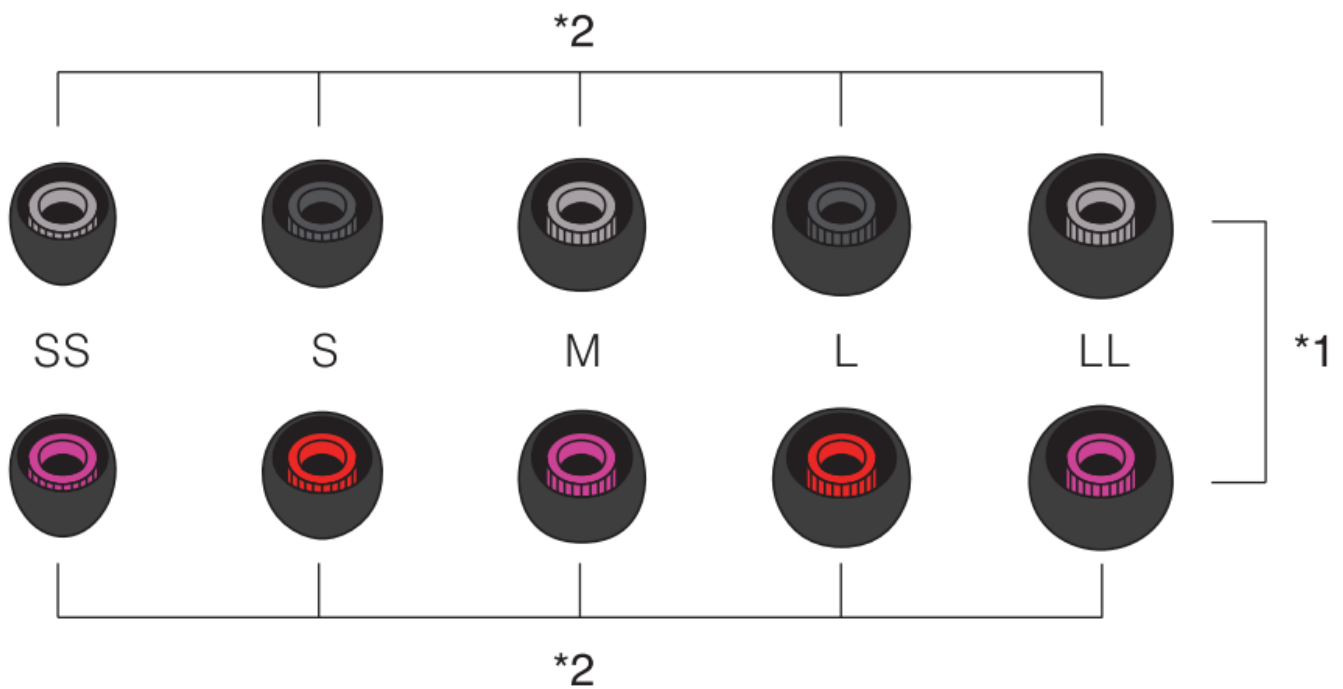

Main unit/ Ear tips

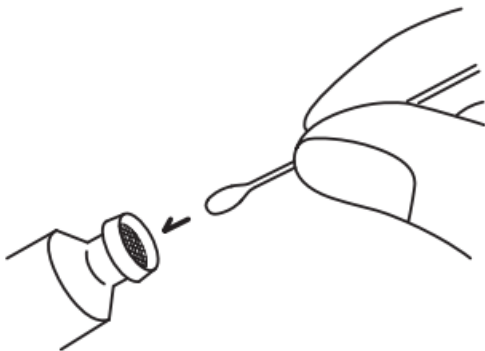
Regarding ear tips

To make it easier to differentiate between the left and right, we have given the cores different colors; the core of one ear tip is gray, while the other is red. (*1) By pulling the sleeve of the ear tip back slightly to check the color of the core, it is easy to distinguish between left and right, even in places with subdued lighting. Since the core colors of neighboring sizes are different (the gray cores alternate between dark and light gray; the red cores alternate between red and pink), it is also easy to distinguish between sizes. (*2)



Maintenance

Please take safety precautions and gently remove any build-up from the dust filter by using a cotton swab.










Warranty and after service

The warranty for this product is valid for 1 years from the day of purchase. During the warranty period, we will repair the product based on the provisions below. The warranty is only valid in the country in which the product was purchased. Please contact the store you purchased the product from regarding questions pertaining to repairs. For products purchased outside your country of residence and for support after the warranty period, please contact us using the Contact Form on our website.

1. During the warranty period, we will repair the product free of charge if the product failed even though it was used in accordance with the instructions in the User's Manual and the Warning and Caution sections.
2. In the following cases, repairs to the product will be subject to a fee even during the warranty period:
3. Original purchase receipt or other documentation showing the date of purchase are failed to be presented.
4. The product is identified to be modified, disassembled, or repaired by a third party or customer other than our company or our authorized organizations.
5. The earphones were subjected to a strong impact or were allowed to get wet. Product failure resulting from an excessive use of force on the product.

6. Failure due to fire, earthquake, wind, flood, lightning, or other acts of God, human error, theft, or virus and malware infection.
7. Repair of scratches on the surface of the housing or repair of the housing itself.
8. We shall not be liable for any incidental or consequential damages for breach of any express or implied warranty or condition on this product. Nor shall recovery of any kind against us be greater than the original purchase price of the product from us or an our authorized dealer.

Notes on Use

 WARNING	Ignoring the content of this indication could result in death or serious injury.
 PROHIBITED	Do not use the earphones while driving a bicycle, car or motorcycle. Doing so could cause a traffic accident and/or serious injury.
 PROHIBITED	Do not use the product while walking in dangerous environments such as near a rail road crossing or intersection where you cannot hear sounds from the outside.
 CAUTION	Ignoring the content of this indication could cause injury or damage to household articles in the vicinity.
 PROHIBITED	When using the earphones, be careful not to play the sound too loud. Doing so for a long period of time could affect your hearing. At 80 dB(A) exposure time shall be limited to 40 hours/week, whereas at 89 dB (A) exposure time shall be limited to 5 hours/week.
 PROHIBITED	If you experience skin irritation, stop using the product immediately and seek medical attention, or consult with our sales agent.
 PROHIBITED	If the sound volume is too loud, sound can be heard by other people. Use care not to disturb other people.

- The way you position the earphone in your ear affects the sound quality. We recommend trying different positions by moving the earphone around while playing music. This will allow you to find the position that generates your most preferred sound. Once you figure out your favorite position it will be easy to set that position each time. The shapes of a person's right ear and left ear are usually different. Therefore, the best position for each ear is usually different as well.
- When removing the earphone from your ears, always hold the main unit first and then remove. Pulling the cord could cause the wire to become disconnected.
- Do not apply strong impacts to the earphones or put excess force on the cable. If the product fails or wires are broken due to abnormal use, the product warranty is invalidated.
- Leaving the product in locations exposed to direct sunlight, high humidity, or a dusty environment could cause the product to fail.
- If the product fails, do not attempt to disassemble.
- The earphone jack is for stereo reproduction only. If the earphone is connected to a monaural output jack, sound may not come out of one side.
