- 3. Footx1




Step 1: Connect the lifting column to the tabletop

Connect the lifting column (2) to the tabletop (1) with M6x12 screws (B) and use the 4×4 allen key (A) to tighten. —11CThr–,




Step 2: Install the foot

Connect the foot (3) to components in STEP 1 with M6x16 screws (C) and use the 4x4 alien key (A) to tighten. .0



Step 3: Adjust the height of the tabletop



Attention

Mobile Standing Desk

All mobile standing desks feature a 5-year warranty for the frame and 3- year warranty for the gas spring system and other mechanisms.

What are your Remedies?

We will replace at no charge to the consumer the defective parts only or, at our option, replace any product or part of the product that is defective because of improper workmanship and/or material, under normal installation, use, service and maintenance. If we are unable to provide a replacement and repair is not practical or cannot be completed in a timely fashion, we may elect to refund the purchase price in exchange for the return of the product. In the rare event that your product is defective, we will provide you with a replacement item shipped at no cost to you within the continental United States. The shipping method for replacement products is FedEx Ground, but expedited shipping is available if you choose to pay the additional expense.
