

INSTALLATION

STEP 1: Install the Columns

NOTE: Please put outer package under the desktop to avoid scratching during installation.

STEP 2: Install the Pedestals

NOTE: The Pedestals are asymmetrical, please pay attention to the direction during installation.

STEP 3: Install the Cable Trays


Note: The bamboo desktop is hard, it is recommended to use an electric drill.

Note: The screws in the wire groove are relatively small, it will cost a few minutes to install.

STEP4: Connect Cable




Connect Column Motors cabels with Handset. Connecting cable ③ should be connected with the other side of Adapter.

STEP5: Install the Baffle

Flip desk over and plug in socket. Then you can use it.

How to Use

Height Adjustment

Press "▲" or "▼" to adjust the height.



Press and hold the button "1", "2", "3" or "4" for 3s to save the current height

To adjust the sensitivity of the anti-collision function, keep pressing "▲" and "▼" simultaneously for 5s to alternate between level 1, 2, or 3.

The indicator levels are as follows:

- "A-1": low sensitivity
- "A-2": medium sensitivity
- "A-3 ": high sensitivity
- "A-0 ": switch off the anti-collision function.

Before switching off the function please make sure there aren't any object under the desk to prevent potential damage.



Press the 3 and 4 keys at the same time, long press for 3S, the reset indication "ASr" or "rSt" will appear, continue to press the "▼" down key until the lift table drops to the lowest position and bounces up

IMPORTANT

Place the mobile phone with wireless charging function on the desktop wireless charging LOGO to charge normally. When the desktop is stationary, each channel can output a maximum of DC5V/2.4A power to the peripherals. Desktop operation is, stop charging, and restart charging after 1 second of inactivity.

Troubleshooting

- Reset: When the LED shows "ASr" or "rSt", press "▼" button until the desk reaches its lowest height and rebounds
 to stop, it means the reset has been finished.
- When it does't work and the LED shows "E01" or "E02", please retry 18 mins later.
- If the "▼" button does't work, please check the cable connection and then cut off the power for at least 10 seconds.

 Reconnect to the power and press "▼" button to start the reset process when it shows the "ASr" or "rSt"
- If all these above process are inefficient, plz contact our customer service.

Attention

- Power supply: AC100V 240V, frequency 50/60HZ;
- Working environment: 32-104°F;
- Before cleaning, you have to unplug the power supply cable. Clean with a slightly damp cloth to wipe away the surface dust. Keep all electrical components away from liquids. Do not damage the connection line and keep the plug in a safe position.
- Inside the control box, there are electronic components, metal parts, plastic parts, wires and so on. They should be disposed in accordance with local laws and regulations. They cannot be disposed of as household waste.
- Before using the product, please make sure the product has been installed correctly.
- Before starting use of the product, please read the instructions to fully understand all the product's functions and settings.

- FlexiSpot Sit-Stand Desktop Workstations
 All standing desks purchased on or after October 5, 2016 include a 5-year warranty for the frame, medium-fiber desktop and mechanisms.
- FlexiSpot Desk Bikes
 - All desk bikes purchased on or after October 5, 2016 include a 3-year warranty for the frame, and a 1-year warranty for the electronics and other mechanisms.
- · FlexiSpot Mini Steppers
 - All desk bikes purchased on or after October 5, 2016 include a 1-year warranty for the frame, and other mechanisms.
- Accessories
 - All monitor mounts purchased on or after October 5, 2016 include a 5-year warranty for the arms, 3-year warranty for gas spring system and mechanisms.

What are your Remedies?

FlexiSpot will replace at no charge to the consumer the defective parts only or, at FlexiSpot's option, replace any product or part of the product that is defective because of improper workmanship and/or material, under normal installation, use, service and maintenance. If FlexiSpot is unable to provide a replacement and repair is not practical or cannot be completed in a timely fashion, FlexiSpot may elect to refund the purchase price in exchange for the return of the product. In the rare event that your FlexiSpot product is defective, we will provide you with a replacement item shipped at no cost to you within the continental United States. The shipping method for replacement products is FedEx Ground, but expedited shipping is available if you choose to pay the additional expense.
