Description

IC T3 Table Lamp by Michael Anastassiades for Flos. The New 2024 IC T3 Table Lamp is part of the IC Collection which explores balance. A series of lights: table lights, wall lights, ceiling pendants, and ceiling mounted lights which take as their basic form a sphere that is perfectly balanced on the edge of a rod. "I came across an online video clip of a contact juggler.

He was spinning a set of spheres, moving them around, and they were spinning so perfectly you couldn't even see them move – they looked perfectly balanced and perfectly still. That was my starting point." – Designer, Michael Anastassiades.

CLAIMS UNDER THIS WARRANTY

MUST BE MADE IN WRITING WITHIN 60 DAYS OF THE APPEARANCE OF A DEFECT AND MUST INCLUDE A COPY OF THE ORIGINAL RECEIPT OR INVOICE.

After reasonable inspection by Flos or an authorized retailer, should a product be deemed defective in materials or workmanship, Flos, at its election, will: (1) replace the defective product with the same model, or a later model of the product or (2) repair the defective product at no cost to the purchaser.
