Unpacking and Setup

Insert the SIM card and battery as per the instructions provided in the user manual.

Powering On and Initial Setup

Press and hold the power button to turn on the Smart Phone.

Follow the on-screen instructions to complete the initial setup, including language selection, Wi-Fi setup, and Google account login.

A: Some models allow for expandable storage via a microSD card. Check the user manual or specifications of your specific model for compatibility.
