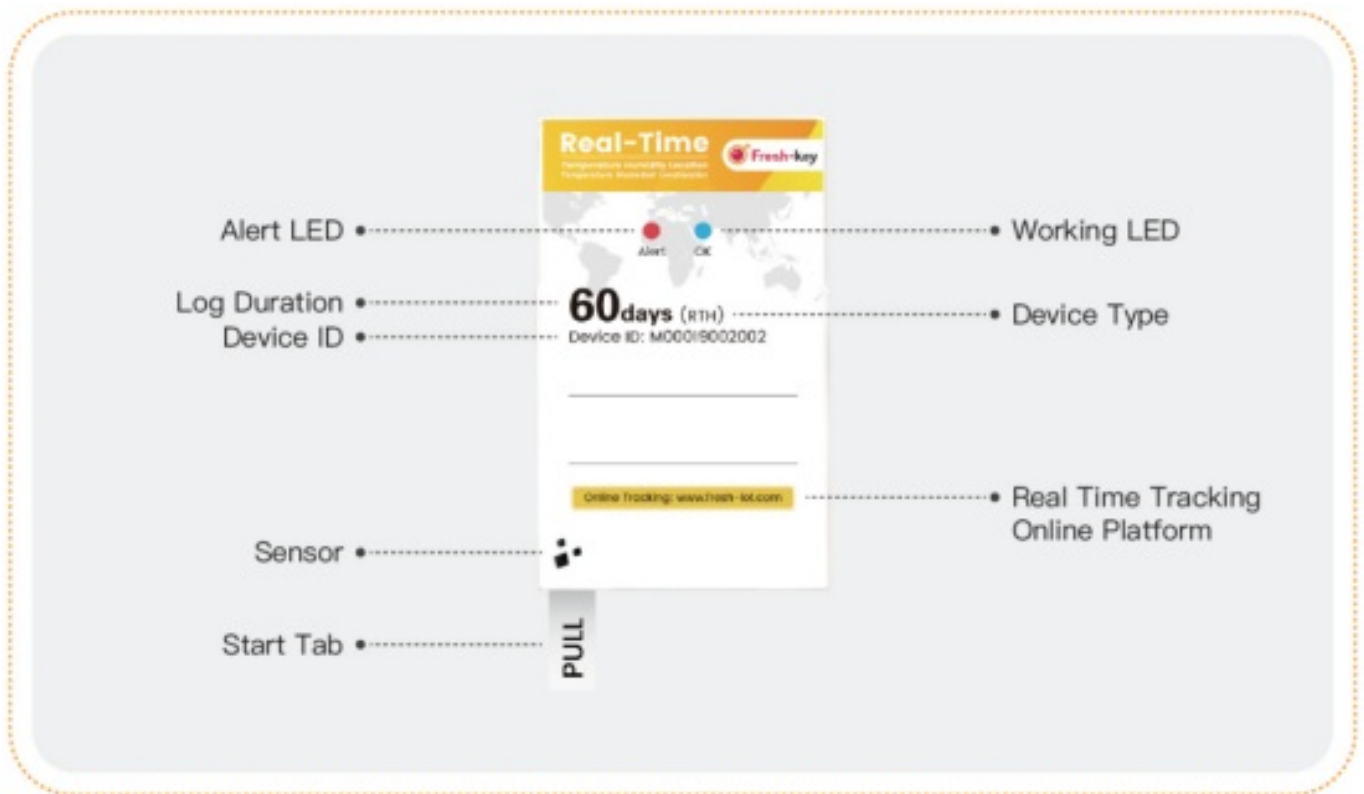

LED Instruction

-  Green LED flashes once every ten seconds – Running Mode
-  Green LED flashes twice every ten seconds – Abnormal Communication

-  Red LED flashes – Function abnormal

How to use •

- Pull out the strip at the bottom of the device to start;
- Log in <http://www.fresh-iot.com>, type in the device ID to track the current temperature humidity and location status;
- In case of abnormal communication or battery issue, please do not use the device and report it through the contact information on the back of the device for replacement.

How to place

- Place the device directly into the package;
- RT device can also be placed in the enclosed sticky bag and attach on the pallets of the container.



Other Notes

- Do not place the device around the fire source to avoid battery damage;
- Do not seal the Fresh-key RTH/RTHL device with plastic packaging, otherwise the humidity collection accuracy will be affected.
