functional characteristics

A7 is a 433.92M wireless remote control, powered by 2 X AAA Alkaline Battery, which has the advantages of strong transmission power, long remote control distance, low power consumption! There are 1 buttons and 1 Knob Actuator, which with the 433.92M receiving module!

Basic functional operation

When the treadmill is powered on, press the start key on the remote control, and the treadmill will down and running.
